EXHIBIT B

RESOLUTION OF THE BOARD REGARDING HAZARDOUS TRAFFIC CONDITIONS

WHEREAS, Education Code 42.155(d) allows the Board of Trustees of \_\_\_\_\_ School District to obtain supplemental state funding for transporting regular, otherwise ineligible students who live within two miles of their school but who would be subject to hazardous traffic conditions if they walked to school;

WHEREAS, the TEA handbook on School Transportation Allotments requires the Board to adopt language providing the definition of hazardous traffic conditions applicable to the District and identifying the specific hazardous areas for which such funding is requested;

WHEREAS, the Board acknowledges the Education Code 42.155(d) provisions stating that a hazardous condition exists where no walkway is provided and students must walk along or cross a freeway or expressway, an underpass, an overpass or a bridge, an uncontrolled major traffic artery, an industrial or commercial area, or another comparable condition;

And the Board of Trustees of \_\_\_\_\_ School District has identified the following specific hazardous areas in which such conditions exist:

West Orange- Cove Elementary School – Located at 2605 MLK. All areas within two miles from West Orange- Cove Elementary School which would require students to walk along or cross MLK, which is moderately to heavy travel thoroughfare.

West Orange- Cove Middle School – Located at 1402 Green. All areas within two miles from West Orange- Cove Middle School which would require students to cross Green Ave. or 16<sup>th</sup> Street which are moderately to heavy travel thoroughfare, all streets east and south of the railroad tracks..

West Orange- Cove High School – Located at 1400 Newton. All areas within two miles from West Orange- Cove High School which would require student cross the railroad tracks.
