Cafeteria serving lines often need to be replaced when they are close to reaching their end of useful life. Over time, equipment components wear out and become unreliable. Specifically, older serving lines lack energy efficiency, increasing utility and maintenance costs, experience frequent mechanical failures, and sometimes do not accommodate current meal service models. Replacing outdated serving lines with modern, energy-efficient equipment improves service speed, food presentation, temperature control, and overall student dining experience, while also reducing long-term operational and maintenance costs.

A Request for Proposal (RFP) #26-004, *Cafeteria Serving Lines – Cedar Bayou Junior School*, was issued to over fifty (50) vendors. Six (6) responses were received and opened by the Purchasing Department on Monday, January 12, 2026, from Ace Mart Restaurant Supply, Bergreen Ellingson, Inc., Culinary Depot (Chef's Depot), Jean's Restaurant Supply, Kommercial Kitchens, and Mission Restaurant Supply.

An evaluation committee, consisting of representatives from relevant departments and campus staff involved in child nutrition operations, was convened to review and assess the proposals. The committee evaluated the response based on the criteria outlined in the RFP. Each category was scored individually, and the totals were compiled to determine the overall ranking.

Based on the evaluation results, the committee unanimously recommends that the contract be awarded to **Kommerical Kitchens**.
