RE: SSP & TSSA Board Memo

Dear Weber School District Board Members and Superintendency,

As you are aware each year schools must submit an evaluation of their TSSA plans that includes what actions they took to achieve their goals and how their funds were spent over the course of the school year. For the 2024-2025 school year, Weber School District received an allocation of \$9,559,469.84 which was distributed to schools based on the 2024-2025 funding model. This model provided schools with an equal base amount and a per student allocation of \$176.58 along with 3.5% to the district office. Schools were provided their allocations prior to the start of the school year and had until June 30, 2025 to expend the funds with an allowed 10% carryover to the next fiscal year. Any amount over the 10% required a plan of action to be submitted in writing to the Director of Assessment, School Improvement & Research and if no plan was submitted any funds beyond that 10% will be funneled towards high need schools to support their School Success Plans during the 2025-2026 school year.

All schools have submitted their evaluations in accordance with 53G-7-1304(5) and are ready for your review as a school board. These items will be placed on the consent calendar for the September 3rd, 2025 board meeting. With the new funding model, new business administrator, and new TSSA procedures, I anticipate a cleaner fiscal year for the coming school year.

Additionally, the 2025-2026 School Success Plans and TSSA budgets are ready for your review. Due to the length of these plans, I felt it prudent to not provide physical copies as that would amount to over 1,000 pages printed for each board member. As an alternative I have created a Shared Drive that is organized by cone. Within each cone's respective folder you will find a folder titled "End of Year Reports" which contains all of the 2024-2025 evaluations. A second folder titled "School Success Plans & TSSA Budgets" contains the 2025-2026 plans. Lastly, there are three appendices attached to this memo. Appendix A is a breakdown of total funds allocated for the 2024-2025 (including previous carryover), and the total funds that will be carried over into the current fiscal year. Appendix B is a breakdown of funds allocated for the 2025-2026 school year. Appendix C provides detailed instructions for accessing the shared drive where all documents will be stored moving forward.

Please take a moment to review any desired plans within the Shared Drive. You may notice varied levels of detail within the plans as some schools grasped the new process faster than others. A variety of opportunities for group and individual coaching were provided and the majority of our administrators took advantage of those opportunities. There are a few plans that still need to be edited due to missing sections or due to a lack

of clarity. Any plans that are edited between now and the September 3rd board meeting will be prefaced with "Updated" and will replace the original plan submitted.

Should you have any questions or concerns regarding the structure of the plans or aspects of a specific school's plan, please know you can reach out prior to the board meeting if you so desire. I sincerely appreciate all the effort put forth by the majority of our administrators and I appreciate your continued support with this new initiative.




