

RECOMMENDATION:						
District Administration is recommending that the Board award the remainder of the work under RFP 2004-056 (Network Equipment & Data Cabling Services) to SBC Global Services, Inc., d/b/a AT & T, Global Services.						
RATIONALE:						
Due to land acquisition issues, the last elementary school (Killam Elementary) is being built outside the initial contract term of The Presidio Corporation who was the primary vendor of RFP 2004-056. As such, The Presidio Corporation cannot be legally obligated to perform according to the agreed upon contract terms, as the contract in question with Presidio has expired. The District, nevertheless, was able to secure the same price from SBC, which is doing business as AT & T and which said company ranked as the secondary vendor, based upon a "best value" determination, to the contract initially awarded to The Presidio Corporation.




