INFORMATION ITEM: Juvenile Officer Janelle Mott was unavailable to present the monthly Child Care Fund Report.

INFORMATION ITEM: Emergency Management and E/911 Services Director Kim Elkie gave the Committee the Emergency Management and E/911 monthly update for January:

- Stats for the month of January for 911 are as follows: 720 Calls for 911 were received; 23 text messages received, and 1,940 CAD entries were made.
- Director Elkie reported Region 7 Homeland Security received grant funding and are offering training throughout the region. Alpena County will be hosting two of the grant funded training courses. An Active Shooter Training will be held in March and a Tactical Emergency Casualty Care Training will be held in April at the Sheriff's Office. The grant total was \$13,200 and just shy of \$8,000 is coming to Alpena County for those trainings.
- Alpena County was invited to become a member of the Northern Michigan Area Committee of
 the Coast Guard. Alpena County has not had a representative on this Committee in quite some
 time and because of our size and being on the lake they are hoping to get our participation.
 Their primary responsibility is to ensure the Committee's readiness to mitigate the impact of an
 incident for public health, the environment, and the economy. Director Elkie will attend a
 Committee meeting this week.

INFORMATION ITEM: Chair Lalonde presented the 2024 Distribution of First Responder Calls for review and approval. Motion was made by Commissioner LaHaie and supported by Commissioner Kozlowski to recommend approval of the action item authorizing the Treasurer to appropriate the Frist Responder Calls payments on a quarterly basis in 2024 as presented.
