Invitation To Bid

The Board of Trustees, Rocky Boy School District #87 J-L, is calling interested parties to submit sealed bids for the removal and replacement of the High School Gym Floor, Box Elder, MT. Scope of work includes The anticipated and expected services within this RFP may include, but not limited to: Removal and disposal of existing gym flooring and sub floor; move bleachers for floor installation; reinstall bleachers after the floor installation and make minor adjustment to insure they are running properly; **removal of tar from the existing concrete slab assuming the slab is in good condition and is capable of holding a concrete anchor. If the existing slab is in poor condition or in not capable of holding a concrete anchor, the concrete slab will need to be repaired or replaced. A change order will be required for approval by the Superintendent of Schools; install a Robbins Bio Channel Star floor system using 2nd and better XL Maple flooring (or similar product). Shim floor system to a height of 3 1/2". System to be shimmed to within a 1/8" variance in a 10' radius; sand and finish gym floor, paint on graphics as designed and approved by the District; provide and Install New Volleyball Floor Covers; approximately 9,870 sq. ft.**

Each Bid Proposal must be accompanied by lawful U.S. money, bank money order, Certified check, Cashier's Check, or Bid Bond payable to the Board of Trustee's, Rocky Boy School District #87 J-L in an amount not less than ten percent (10%) of the total bid amount. Successful bidder shall furnish an approved Performance Bond and Labor and Materials Payment Bond each in the amount of one hundred percent (100%) of the contract amount. Insurance coverage shall be provided by the successful bidder and a certificate of insurance shall be provided. The procurement of these services will be subject to a preference for qualified Indian organizations or Indian-owned economic enterprises, and Chippewa-Cree TERO requirements shall apply. The project is subject to Federal Davis-Bacon wage rates. Successful bidder must certify in writing that project will be completed between April 15, 2019 and July 15, 2019. A penalty of five percent (5%) per day after July 15, will be assessed if
