Memorandum of Understanding Between Region 11 Education Service Center And

The Region 11 Education Service Center will provide direct student services, family support services, technical assistance, and staff development opportunities to districts as described in this agreement. The delivery of these services as described is contingent upon sufficient funding from the Office of Head Start.

Direct student services will be provided to prekindergarten children who qualify for Head Start services. Direct student services are available through the Education/Family Literacy, Family Services, Health, Mental Wellness and Disabilities service areas.

Staff development and technical assistance will include: on-site technical assistance for Head Start teachers, instructional assistants, family services assistants and/or home visitors. Staff development and technical assistance are available through the Administrative, Education, Family Services, Health, Mental Wellness, and Disabilities service areas.

Roles and Responsibilities of the School District:

- 1. Identify through appropriate documentation eligible Head Start children and maintain full enrollment and an active waiting list at all times
- 2. Provide classroom space and maintenance of space for Head Start classes
- 3. Operate the Head Start program according to local program guidelines and Head Start Performance Standards and other pertinent Administration for Children and Families regulations, adhere to the Standards of Conduct, and ensure that two staff members are with the children at all times
- 4. Operate all classes for at least six (6) hours per day
- 5. Provide two meals and a snack for children during the school day
- 6. Provide certified teacher for the Head Start classroom to implement a scientifically based curriculum, including educational activities, curriculum objectives and instruction

- 7. Provide written documentation to Region 11 ESC as needed to fulfill fiscal and programmatic requirements, including in-kind non-federal share community match to the federal grant
- 8. Permit Region 11 Head Start program specialists to provide on-site technical assistance as needed
- 9. Provide release time for Head Start staff to attend staff development
- 10. Permit teachers to conduct at least two home visits with the Head Start families per year
- 11. Permit Head Start children and assigned classroom staff to eat together, sharing the same menu, to the extent possible
- 12. Invite Head Start Specialists to ARD meetings for Head Start and potential Head start children
- 13. Forward appropriate Special Education documentation for Head Start children to Head Start Specialists
- 14. Ensure that Head Start classes do not become a Special Education setting, but support an inclusion philosophy
- 15. Maintain evidence of automobile liability insurance for district Head Start staff
- 16.Provide substitutes for classroom staff to maintain the Head Start child/adult ratio at all times
- 17.Pay for substitutes for classroom staff when absent due to reasons other than approved Head Start requirements
- 18.Disseminate Head Start and Pre-K information to families and provide access to programs
- 19. Allow family services assistants to explore community resources for the provision of additional services to meet the needs of working parents as applicable
- 20. Communicate with parents to ensure smooth transitions to kindergarten or Pre-K

Roles and Responsibilities of the Education Service Center

- 1. Serve as fiscal agent for the Head Start program and ensure the compliance of all program requirements
- 2. Provide staff development for Head Start including opportunities for joint staff trainings

- 3. Establish appropriate policy council and advisory committees according to program requirements
- 4. Provide technical assistance
- 5. Purchase equipment and materials to fulfill program requirements
- 6. Assign staff to provide appropriate direct student services and family support services
- 7. Reimburse school districts for snacks provided to Head Start children
- 8. Provide accident insurance for Head Start children during school hours as part of a blanket policy for all Head Start children in the region
- 9. Reimburse the district for stall allocated on the annual Head Start salary budget form at the rates outlined on that form
- 10.Reimburse Head Start staff for transporting children for medical and dental appointments (Region 11 will <u>not</u> provide transportation to and from school)
- 11.Reimburse Head Start staff or the district (if a district vehicle is used) for work-related mileage
- 12.Reimburse school district for substitute pay when Head Start staff attends approved required trainings
- 13.Pay a stipend to Head Start staff for days worked outside of the ISD employment calendar to fulfill the Head Start Performance Standards with prior approval by a Head Start administrator
- 14. Determine selection priority for eligible children and service areas
