Re: Bid Results and Recommendations

On January 30, 2019, bids for seven trade packages related to three projects at Westfield and DuJardin Schools were publicly opened and read out loud. The three projects include roof replacement at DuJardin, adding air conditioning to the gym at DuJardin, and structural wall repairs at Westfield. A total of 21 individual bids were received for six of the seven trade packages. No bids were received for structural steel but our Construction Manager, Frederick Quinn Corporation, obtained three quotes from steel contractors. The following pages have a breakdown of the bids and recommendations. Below is a table that lists the total costs, including fees and a 5% contingency, for each project and the grand total of all three projects.
