Security Audits

- Senate Bill 11 79th Legislative Session
- Effective September 1, 2005
- "At least once every three years, a school district shall conduct a security audit of the district's facilities. To the extent possible, a district shall follow security audit procedures developed by the Texas School Safety Center or a comparable public or private entity."
- DISD finished 1st cycle in 2008; 2nd cycle in 2011, 3rd cycle in May, 2015, and completed first year of 4th cycle
- Eifty one (-1) buildings

District Response to Security Audits Findings

- Card access systems at all campuses
- Increased camera coverage
- Increase secured entrances to early childhood, elementary, middle school and high school campuses
- Increased emphasis on lockdown drills; standardizing procedure district-wide

Response to Security Audit Findings

- Improved campus EOP's
- Increased interaction with local law enforcement
- Improved campus visitor procedures
- Numbered all exterior doors inside and outside

Training

- Law enforcement agencies have used our buildings to practice active shooter training
- Tabletop exercises with the Denton Police Department and Denton County Sheriff's Department
- All DISD administrators have completed ICS 100 for Schools
- Participation in Denton Emergency Preparedness Advisory Council (DEPAC)
- Participation in the DEPAC yearly Mock Disaster Drill (2013 drill at C. H. Collins Stadium)
- Watch D.O.G.S. Dads of Great Students

RESPONSE

- Follow the EOP to minimize casualties or property damage
- Many members of the Denton ISD Audit Team are Operations personnel
- Remarks by team members outside Operations how quickly physical problems in the audit are corrected
- Training prepares for a quick decisive response

RECOVERY

- Short-term recovery efforts seek to restore vital services to DISD facilities and provide for the basic need of staff and students
- Long-term recovery focuses on the restoring the district to its normal state
- Examples of recovery programs include temporary relocation of classes, restoration of school services, debris removal, disaster mental health services and reconstruction of damaged facilities
