Administrative Consideration:

- Instructional material adoption and selection processes utilize teachers in the impacted courses to review and evaluate materials. The processes are facilitated by personnel from CTE.
 - LISD utilizes teacher review teams for obtaining maximum amount of input on instructional materials. The following CTE review teams have been created:
 - Any CTE teacher in the district that currently teaches or supports within that Program of Study had the opportunity to provide feedback on all resources available for consideration.
 - CTE Administrators also worked alongside the instructors for support

throughout the evaluation process.

- Instructional materials are selected based on their alignment with the TEKS.
