## **Opening and Call to Order**

Chair McBee called the special board meeting to order at 6:00 p.m. and welcomed the guests. Mrs. McBee reminded those in attendance that the meeting is audio recorded. The group recited the Pledge of Allegiance.

### 2017-2018 School Calendar

Brad Bixler presented to the board two revised gold and green calendars for the 2017-2018 school year for the board to review. Mr. Bixler pointed out the difference in the spring conference dates on both proposals. Brad stated that the staff survey that was completed by the staff was in support of the green calendar.

## **Budget Priorities**

Chair McBee explained that the state legislator's budget process could stretch into a special session late this summer and leave us struggling to predict the future. Our district has to provide a balanced budget in May. Mrs. McBee explained that we are doing everything we can, including the use of \$1 million of the district's \$1.75 million contingency funds as a way to minimize the impact of the budget shortfall. Debbie communicated that we do not want to lose any staff on any level, nor do we want a mass exodus because of a budget situation that is affecting our district. We ask our staff to be patient in this process to know that we are being as responsible and thoughtful as we can be and we understand the stress that this decision brings to everyone. We urge people to contact the Oregon legislators to push for more education dollars.

Michele Jones stated that administration team is looking at all programs and other areas of the budget that can be tightened or eliminated. Mrs. Jones noted that the kindergarten registration numbers are not high and with the already declining enrollment she would like to set the budget at \$7.8 billion.

Superintendent Kovach read a budget update statement. He stated that he asked the administrative team to prepare the district's budget with contingencies that allow us to adjust for range of revenue levels. Mr. Kovach noted that the administrative team will be looking at all programs and other areas of the budget that can be tightened or eliminated first and that we all understand how difficult a decision this is for the board and only as a last resort will decisions be made that affect personnel.

### Approval of Authority to Proceed with Reduction in Force

A motion due to budget constraints for 2017-2018 school year, the board approves the superintendent and his administrative team to develop a reduction of force plan to include administration, certified, classified, and confidential staff was made by Dale Freeman, and seconded by Steve Umbarger, Motion was amended.

After discussion the board agreed to the following amendment to the motion:

A motion due to budget constraints for 2017-2018 school year, the board authorizes the superintendent and his administrative team to develop a plan that includes the use of contingency funds, absorption of positions through retirements and resignations, evaluation of programs, and potential reduction in force which could include administration, certified, classified, and confidential staff, was made by Dave Krumbein, seconded by Gary George, and approved unanimously by the board.
