TITLE: Approval of Out of State Travel

BACKGROUND:

STUDENTS

Meghan Lloyd, Kaitlin Lloyd, and Taylor Shultz from Ironwood Ridge High School request permission to take 9 students from the Dance Team to Orlando, Florida, January 30-February 3, 2014. Approximate cost of the travel is \$13,992 and will be paid for by booster club funds. Three school days will be missed and substitutes are not required.
