

**COLLIN COUNTY COMMUNITY COLLEGE DISTRICT
BOARD OF TRUSTEES
Meeting Minutes
August 26, 2014**

The Collin County Community College District (“Collin College” or “District”) conducted its regular monthly Board of Trustees meeting on August 26, 2014, in the Board Room, Room 139, Collin Higher Education Center, with Chairman Mac Hendricks presiding. Trustees in attendance were Ms. Stacy Anne Arias, Dr. J. Robert Collins, Mr. Andy Hardin, Ms. Jenny McCall, Mr. Adrian Rodriguez, Mr. Larry Wainwright, and Ms. Nancy Wurzman. Other attendees included District President Cary A. Israel, Collin College administrators, faculty, students, staff, and community members.

CALL TO ORDER

Chairman Hendricks called the August 26, 2014, meeting of the Board of Trustees of Collin County Community College District to order at 5:32 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.

2014-8-5-1g Employee Tuition Reimbursement

WHEREAS, Collin College is committed to its Core Values that include having a passion for Learning and Academic Excellence, AND

WHEREAS, the tuition assistance plan provided to faculty and staff is not only a benefit and a workplace incentive, but also a program that is likely to result in a number of workforce benefits, including:

- an increased number of employees who begin, make progress toward or complete associate, bachelor and graduate degrees, resulting in a more educated, knowledgeable and capable workforce;
- a reduction in employees' future debt;

- a visible demonstration of the college's commitment to the professional development of Collin employees and to its Core Values; AND

WHEREAS, the college district's employee tuition reimbursement benefit plan has remained at \$400 per employee per year since 1994 and the cost of tuition at area colleges and universities has risen significantly during that period, NOW THEREFORE

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves an increase in the amount of tuition reimbursement to \$800 per employee per year, consistent with the procedures and guidelines established to administer employee tuition reimbursement and as published on the Human Resources web page.

2014-8-5-1h Faculty, Staff, Administrator and President's Compensation

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of the Collin County Community College District approves a budgeted salary and wage increase for faculty, staff, and administrators, of generally 4%, with approved merit, market, and range adjustments within the college's approved compensation structure. On recommendation of the Board of Trustees, the President is included in this budget salary and wage increase.

President Israel thanked the Board of Trustees for looking at the college's compensation and going the extra mile to insure that the District has competitive salaries.

2014-8-5-2 Approval of the Permanent Expulsion of a Student

President Israel said the Board of Trustees had been fully informed and discussed the facts regarding the request to permanently expel a student in executive session. In keeping with FERPA privacy laws, the information could not be discussed in open session; however, the first expulsion concerned dishonesty related to documentation.

On motion of Mr. Wainwright, seconded by Ms. Wurzman, the Board of Trustees of Collin County Community College District unanimously approved the permanent expulsion of a student.

President Israel reviewed the proposed changes in these local policies as follows:

DC – Language has been added to strengthen the focus on recruiting outstanding applicants and to acknowledge the role of supervisors in ensuring a fair and impartial evaluation of all candidates.

DHB – Addition of the right to conduct searches. Addition of the ability to conduct drug testing for safety-sensitive positions and as otherwise permitted by policy (e.g. worker's compensation).

DI – The purpose for DI (local) changed and the content moved to DJ (local). The content reflected in DI (local) is a policy code that TASB is no longer using. The change proposed in the new DI (local) requires notification with three calendar days rather than five and notification to the immediate supervisor for violations of a criminal drug statute occurring in the workplace.

DIA – DIA (local) is a new policy code and content was moved from DOA (local), which has been deleted. Veteran status was added to the list of protected employee groups. The Deputy Title IX Coordinator contact information was added.

DJ – DJ (local) is a new policy code and content was moved from DI (local). A paragraph describing regular faculty assignments was added. Based on our current practices, we have eliminated the sentence that states that holiday hours are considered as hours worked. Holiday hours do not count toward the calculation of overtime within a workweek. All language related to timesheets has also been deleted since we now have an on-line timekeeping system.

DMAC – Deleted policy code. Content moved to DMD (local).
DMAD - Deleted policy code. Content moved to DMC (local).
DMC – New policy code. Content moved from DMAD (local).
DMD – New policy code. Content moved from DMAC (local).

2014-8-5-5 Approval and Adoption of 2014-2015 Budget

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves and adopts the Fiscal Year 2014-2015 budget as presented in the amount of \$181,166,701 for Current Funds (operating, auxiliary, and grants/contracts); \$31,873,917 for the Building Fund expenditures, and \$5,576,172 for the General Obligation and Revenue Debt Service Funds. The total budget being \$218,616,790 with said funds to be appropriated to the various expenditure accounts as outlined in the budget document “Proposed Annual Budget Fiscal Year 2014-2015.”

Vice President/CFO Ralph Hall presented the proposed budget for FY2014-2015. Chairman Hendricks explained that the revised proposed tax rate upon which the budget was developed was a rate of \$0.081960, the lowest the District’s tax rate has been in 25 years. He said the board and administration had worked hard on the budget and appreciated everyone’s hard work. President Israel thanked the board members for their due diligence.

On motion of Mr. Wainwright, second of Mr. Rodriguez, the Board of Trustees of Collin County Community College District unanimously approved and adopted the Fiscal Year 2014-2015 budget as presented in the amount of \$181,166,701 for Current Funds (operating, auxiliary, and grants/contracts); \$31,873,917 for the Building Fund expenditures, and \$5,576,172 for the General Obligation and Revenue Debt Service Funds. The total budget being \$218,616,790 with said funds to be appropriated to the various expenditure accounts as outlined in the budget document “Proposed Annual Budget Fiscal Year 2014-2015.”

2014-8-5-6 Approval of a Resolution Setting the 2014 Tax Rate

WHEREAS, at its meeting of August 5, 2014, the Board of Trustees of Collin County Community College District, voted on a proposed tax rate for 2014, and

WHEREAS, in subsequent meetings with appraisal district and taxing representatives additional analysis/data was obtained and reviewed, NOW THEREFORE,

BE IT RESOLVED, at the recommendation of the President, that the Board of Trustees of Collin County Community College District approves setting the tax rate for 2014.

Dr. Collins made a motion to approve the tax rate, seconded by Ms. Arias. Dr. Collins amended the motion, with approval of the second, to move that property taxes be increased by the adoption of a tax rate of \$0.081960, which includes a Maintenance and Operation rate of \$0.078965 and a Debt Service Rate of \$0.002995. The motion was unanimously approved.

The adoption of the 2014 tax rate of \$0.081960 represents a lower rate than last year's rate of \$0.083643.

On motion of Dr. Collins, second of Mr. Rodriguez, the Board of Trustees of Collin County Community College District unanimously approved the Bid Report for August 26, 2014.

Dr. Collins asked Chief Information Systems Officer David Hoyt several questions regarding Bid 3502 for Oracle hardware. President Israel said that the Texas Connection Consortium had been established to work with Oracle to save money for institutions and resolved issues. Trustee Collins suggested that it might be appropriate to establish a "U.S. Connection" for all those Oracle users around the nation who are a captive market. He said a connection like that could get together and define what they need or even create a product. President Israel said he would earmark this as an issue to investigate.

Budget Status Report as of 07/31/14

For the month ending July 31, 2014, expenditures exceeded revenue by \$22,735,168. Year-to-date expenditures exceeded revenue by \$956,333.

Investment Schedule as of 07/31/14

Investments for the month of July totaled \$251,928,064 with TexPool paying .03% and TexStar paying .03%. One Federal Home Loan Bank was paying .09% and a Fannie Mae was .13%. The U.S. Treasury benchmark was .04% on July 1, 2014, and .03% on July 31, 2014. Three short-term certificates of deposit with Bank of America are paying .13%, .11% and .11% respectively.

President Israel announced the following:

1. Thank you to the Board of Trustees for its hard work and stamina with all the meetings this month. We very much appreciate the approval of salary increases, increase in tuition reimbursement and everything the board has done for the employees this month.
2. Today in 1920, the 19th amendment certified women's right to vote.
3. At its gala on August 22, Collin's Engineering Technology Department was named the Tech Titans of the Future – University Level by the Metroplex Technology Business Council. The Tech Titan program recognizes the most elite in North Texas technology – individuals currently transforming the high-tech industry and giving companies that competitive edge. In addition to the recognition, the award came with a \$25,000 prize. Our competition was stiff with two programs at UT-Dallas and the Industrial Engineering Senior Design program at A&M Commerce. 8. The service learning project of Professor Suzanne Jones' class was recently highlighted in a story on NCB Channel 5's "Tell Me Something Good" segment. As its research project, the class was assigned to write a community action proposal for the Samaritan Inn, Collin County's homeless shelter. Kudos to Professor Jones who teaches College Success, Integrated Reading and Writing at Collin and is the faculty coordinator to the Center for Scholarly & Civic Engagement.

President Israel wished a belated Happy Birthday to Trustee Arias.

The Board announced the following:

Trustee Rodriguez said he applauds Dr. Israel, the faculty and staff for their continuing work. He announced that September 15 through October 15 is Hispanic Heritage Month.

Trustee Hardin said for those watching via streaming, the board holds vigorous debate and discussion on the items that it considers. He said he did not want to give the casual observer the impression that the board votes yes on everything or that it takes any of its work lightly. Sometimes it may appear that the approval of agenda items come easy, but they are not without the board's questions and discussions. He said he was pleased that the board was able to lower the tax rate while giving a pay increase to employees. Collin College continues to have one of the lowest tuition rates and he is grateful that the board is a beneficiary of being in the right place at the right time and able to do the right things.

Trustee Arias said she was honored to be part of the vote to give a 4% increase to employees. She said the board appreciated and supported the employees and will continue to do what it can to show that support.

Trustee Wainwright said he was proud to give a pay rate to faculty and staff that they deserved, pleased to lower the tax rate, and to pass on savings for books to the students. He said the savings on books is a big step forward and puts money in the students' hands so that they can continue their education.

Trustee Wurzman echoed the other comments.

Trustee Collins said there were many good things talked about tonight. The 4% increase in salaries was just one. He recalled a few years ago when money was tight and the board said it would do better when it could, and this is that year. Dr. Collins said he was glad the mistake in employee tuition reimbursement was caught and that the board was able to double the reimbursement amount. He added that the tax rate was lowered 4.18%. If you look at the college's trends, the tax rate has been going downward for the last eight or 9 years and the board was able to lower it again this year, which is significant.

Dr. Collins thanked Bobbie Long for the work she has done in establishing a fine library system and as an example of the faculty and staff who have a commitment to the District. He said the faculty and staff are driven by a passion for the college, and he really appreciates that passion. Trustee Collins said the board does not only want to be the

best in Texas, but rather the best in the nation. He said when he hears President Israel's reports, it underscores that Collin College wants to be the best in the nation.

Trustee McCall thanked everyone for their work and wished Happy Birthday to Trustee Arias.

Chairman Hendricks thanked the faculty and staff because they are "what makes this institution." He said the board approved \$65 million for salary and benefits because of the employees' talents. Chair Hendricks said the board had just finished President Israel's evaluation and that the District is very fortunate to have him at the helm. All of the trustees are in agreement and back Dr. Israel 100%. Chairman Hendricks said the board is looking forward to another decade of excellence.
