As its March 18, 2014 meeting, the Board of Education approved award of a contract to Thyssen Krupps, Inc. for the pre-purchase of an elevator at Whittier School in the total amount of \$58,800. Following that, the District's architectural firm, STR Partners, LLC, prepared a bid specification for the construction renovation work associated with not only the full accessibility of Whittier School but smaller accessibility projects at Beye, Irving and Mann Schools. The appropriate bid notice was published in the March 5, 2014 issue of the <u>Wednesday Journal</u>, announcing a pre-bid meeting on March 25, 2014 and bids being due on April 2, 2014. Besides the public notice, STR Partners reached out to six other construction companies of a size appropriate for this undertaking and four companies obtained construction documents. However, of those four, only two firms submitted a bid. STR has learned, after reaching out to those other potential bidders as to why they chose not to submit a bid, "that the electrical contractors are experiencing an upturn in work and some felt the scope of this project was not sufficient to gain immediate attention in submitting pricing during the allotted bid period".

Attached are three documents:

- 1. Letter of recommendation from STR Partners, LLC to award this contract to CMM Group, Inc.
- 2. A letter from CMM Group, Inc. affirming acceptance of submitted bid amount.
- 3. Bid tabulation sheet

CMM Group, Inc. has worked with STR Partners in the past and is currently working with Henry Brothers as the construction manager in District 200/Oak Park River Forest High School. They have also worked on several Park District buildings in Oak Park over the past few years.

Below is a delineation of original estimate and bid prices for this work, coupled with expansion of this project, given the additional renovation work required for the two Early Childhood classrooms (coming from Holmes) and the necessary relocation of the existing Art Room (from 1st to 2nd floor) due to Early Childhood classrooms taking original Art Room Space.

The additional work for the Early Childhood, Art Room and unit ventilator work is being supported by funding from Special Education (\$433,958). The Director of Special Education, Mike Padavic, has amended his IDEA grant to support this work as well as his allocation of some of the 2014-15 Medicaid monies. The smaller ADA renovation work at Beye, Irving & Mann (\$120,900) will be funded through use of the District's current Life/Safety fund balance. The remaining balance of \$1,012,572 will be funded as previously identified (the 2011 and 2012 Madison Street TIF dollars).

The variance between estimate and actual is "good news" given that the overall bids received were \$544,086 below estimate. However, you may recall that as the architect was presenting the estimates, she indicated that these numbers were preliminary until some stronger definition could be provided through the actual bid documents.

Therefore, I support the recommendation of the District's architectural firm, STR Partners, LLC., in awarding a contract to CMM Group, Inc., in the amount of \$1,508,630 for the accessibility renovation work at Beye, Irving, Mann & Whittier Schools. Jennifer Costanzo will be present at Tuesday evening's meeting for any further clarifications and/or explanations.

FAC will review this material at its April 15, 2014 meeting and an approval from the Board will be sought at its April 29, 2014 meeting.
