Joint Work Session with Tillamook Bay Community College:

Mr. Ryan called the work session to order at 5:43 p.m. Mr. Erlebach asked that everyone introduce themselves. Mr. Erlebach shared that NKN is excited to have an active partner with Tillamook Bay Community College (TBCC).

#### Status of TBCC NKN Campus:

Invited the TBCC board to take a tour of the TBCC classrooms after the meeting, he explained that the TBCC bond contributed \$450,000 to the project and Neah-Kah-Nie School District contributed \$70,000.

Ms. Buckmaster shared that we love our dual credit classrooms and the Technology available in them. Students and staff are learning to use technology better and better. Mr. Erlebach asked Ms. Buckmaster to brag about her Smarter Balanced scores. Ms. Buckmaster stated that the high school had 80 percent of students meet or exceed in writing and reading which are combined with the Smarter Balance assessment. The scores lend a lot of credence to the use of technology.

Ms. Green provided a handout that showed the number of credits taken by NKN student in 2013-14 and 2014-15, the cost savings to students, number of placement test offered at no cost to students, and dual credit classes. Ms. Green's handout is attached to these minutes.

- First Class Scholar Program students with a 3.0 can have their first two years at TBCC paid for. In 2014-15 we had one student participate. In 2015-16 we have potentially 2 students take advantage of the program
- Expanded Options allows students to take college classes at a discount, the tuition is discounted by 20% there were 16 expanded options courses available to students
- Dual credit taught by a TBCC approved high school teacher, course is a college level class, and the student receives both high school and college credit. TBCC does not charge the student or the high school for dual credit classes

Mr. Ryan mentioned that he would like to have a conversation about how we partner and market the opportunities available to students here. Mr. Ryan shared that the original thought was that if you put it in their back yard they will come. TBCC is open to suggestions. Discussion occurred. Mr. Erlebach mentioned that NKN can put out information to parents via newsletters. Additionally we do not have TBCC as a community partner on our website, this will be updated tomorrow.

Ms. Buckmaster explained the Willamette Promise. Neah-Kah-Nie High School has 6 teachers who have attended the first Willamette Promise teacher training. Students take dual credit, high school classes that are aligned to the Western Oregon curriculum, pass a proficiency exam, then the student would qualify for Western Oregon University credit. It is a \$30 unlimited credit opportunity for students. We are in the very infant stages of the Willamette Promise partnership. The high school teachers need to do the work to overlap what our curriculum is with the Willamette Promise proficiency standards. Additionally, Neah-Kah-Nie High School teachers work with college professors to score the proficiency exams. Ms. Green stated that it could be a great program, but she feels it has not been fully vetted yet. She feels that some things need to be worked out. There are colleges who have pulled out of the program and some that have said they will question all Western credits. Ms. Green stated that TBCC is not participating.

Mr. Erlebach mentioned that before there was Western Promise, there was Eastern Promise. Ms. Green explained the Eastern Promise model. In her opinion Western Promise has not been fully replicated after Eastern Promise, a program that is working really well. Discussion occurred.

Mr. Ryan stated that there are many more questions than we can answer at this time. Mr. Ryan stated that each board has another meeting to run. He thanked the TBCC board for coming to meet with the Neah-Kah-Nie board. He shared that the TBCC board will meet in room six across the hall.

Mr. Tish thanked TBCC for what is occurring between the two schools. He also mentioned a young lady who worked for him who used the First Class Scholarship program and went on to Portland State University, has \$20,000 increase in her savings account and no debt. He stated that it is a great deal. He mentioned the Hospitality and Tourism program, we have an exceptional individual in Alan Joynson. He would like to see that program grow. It is a tremendous growth opportunity for students and for our communities.

# TBCC and NKN shared programs to support student success

TBCC and NKN high school have been working together on projects to assist students in high school receive college credit and in delivering classes to the community. As part of our discussion for the shared Board workshop, TBCC is providing the following information. Some previous years' numbers (2013-2014) may have been edited for accuracy and consistency.

Highlights for the conversation for the shared Board workshop on September 14<sup>th</sup> include:

- 1. **TBCC commitment** to high students obtaining career and college readiness and credits:
  - First Class Scholarships (FCS) for all NKN graduates with a 3.0 for transfer or a 2.5 for CTE and place into college level classes. In 2014/2015 1 NKN graduate and for 2015/2016 potentially 2 graduates have taken advantage of this (one returning student and one new FCS).
  - Expanded options. The college provides a 20% reduced tuition for NKN HS students who are approved to take college level classes at TBCC while attending NKN. In 2014/2015 16 expanded options courses, compared to 17 expanded options courses in 2013/2104, were taken by NKN students at this reduced tuition option.
  - <u>Dual credit courses</u> when a HS instructor is approved by TBCC to teach a college level class that is transcripted at TBCC and that is also used for HS credit. In 2013/2014 19 courses were taken by 119 (duplicated) NKN students in the dual credit options. In 2014/2015 17 courses were taken by 148 (duplicated) students. TBCC charges no tuition for enrollment in these courses to either the student or the high school.
- 2. When considering <u>both</u> dual credit and expanded options courses, in 2014/2015 as compared to 2013/2014:
