This letter transmits an update from Plante Moran Realpoint (PMR) as it relates to the assignment to assist and advise the Novi Community School District (NCSD) in the procurement of Furniture for the 6<sup>th</sup> Grade House Renovations (Project). This update represents the mutual efforts of PMR, C2AE, and NCSD Administration (The Project Team) to present a framework to identify, evaluate and recommend vendors for this Project.

## SELECTION PROCESS

C2AE worked collaboratively with District administration, user groups, and District staff to identify needs, design required furniture, and make the necessary selections regarding the furniture package for the following user groups / spaces: Administration, Robotics, Adult Education, Special Education, and Japanese School. Pricing was received from multiple vendors via cooperative pricing.

## RECOMMENDATION

Per the attached recommendation letter provided by C2AE dated April 23, 2025, PMR is recommending award to multiple vendors per the attached. Upon approval the District will execute multiple purchase orders to these vendors totaling below. This scope for these purchases will be funded from budgets established for the 2019 Bond Program under FFE (Fixtures, Furniture, Equipment). Initial budgets established for this scope was \$2,000,000.00.
