Change Order 002 – Northstar Builders

SUMMARY:

This item requests approval of Change Order 002 assigned to Northstar Builders for the Ryan High School Athletic Additions & Renovations project to allow for renovations to be done to the C.H. Collins Athletic Facility.

PREVIOUS BOARD ACTION:

The current Northstar Builders contract was approved by the Denton ISD Board of Trustees on March 24, 2020. Change order #001 was approved on April 14, 2020 for the District Bus Transportation Facility.

BACKGROUND INFORMATION:

This change order will add renovations to the C.H. Collins Athletic Facility to the current Northstar Builders contract previously executed for the Ryan High School Fine Arts, Athletic Additions & Renovations. The original GMP for the renovations and additions at Ryan High School was \$49,486,486.00, Adding the C.H. Collins Athletic Facility renovations to the Northstar Builders contract approved by the board on March 24, 2020 will increase the GMP for the project by \$747,389.00. The new GMP for the combined Ryan High School Fine Arts, Athletic Additions & Renovations, the District Bus Transportation Facility, and the C.H. Collins Athletic Facility renovations is \$51,197,318.00. Other items outside of the Northstar Builders Contract result in a total project cost of \$51,840,630.00
