TEA REMARKS

Dr. Abe Saavedra, TEA: Mr. Lopez, Members of the Board, first of all congratulations on the successful start of another school year. I congratulate of course the Board, the administration, the school staff, the teachers and everybody. You had a very successful Convocation, I attended that, it was a great way to start off the school year. I also congratulate the re-elected board members that are returning. I think that the fact that no other individual challenged incumbent board members suggests that the community is satisfied with how you are dealing with the school system and decision you're making and so forth. It could also communicate lack of involvement on the part of your community. So I would encourage the board to consider that so that in future elections there's a stronger effort made to bring the community in. We had talked about it one time, you may recall, to have information meetings. A democracy works when the community is involved and so I would encourage you to consider that. Also, congrats on what seems to be a balanced budget that you will adopt later tonight. It's one of the requirements that TEA had put out there as well as a 3-month fund balance which seems to be in place as well so things seem to be going well, always room for improvement but things seem to be going well at this point. Thank you.

SUPERINTENDENT'S REMARKS (NO ACTION / REPORT ONLY)

Henry Yzaguirre, Superintendent of Schools, addressed the Board and audience, he congratulated all staff on the good start this school year. He informed that our athletics are underway. He acknowledged that it is hot outside and he said that precautions are being made to keep students and staff safe. He stated that we are monitoring and participating in CPS curtailments and advised that we do not shut down during the school day. He congratulated Mr. Gutierrez and his operations team certain for their response when needed. He discussed attendance, stating that last year on school day 8 we had 7,254 students and this year day 8 we had 7,326. The Superintendent recognized HR as they put in a lot of time and effort this summer. He recognized Mr. Gutierrez's and Mr. Rocha's staff for getting the schools ready for the year, and he recognized the Board completing their Head Start governance training.

OPEN SESSION

 Discussion and possible action to censure Shirley Ibarra, Trustee District 4, for incompetency arising from gross carelessness, unfitness or inability to promptly and properly discharge official duties, official misconduct, neglect of duty, and dereliction of duty. Mr. Flores made a motion: I move that the South San Board of Trustees adopt the Resolution of censure against Trustee Shirley Ibarra for incompetence and dereliction of duty, Mr. Araiza seconded, Mr. Lopez read the Resolution into the record:

RESOLUTION OF THE SOUTH SAN ANTONIO INDEPENDENT SCHOOL DISTRICT BOARD OF TRUSTEES CENSURING TRUSTEE SHIRLEY IBARRA

WHEREAS, the South San Antonio Independent School District ("District") Board of Trustees affirms that education is the most important function of state and local governments. The Board of Trustees epitomizes representative and participatory government — citizens elected from our community making decisions about educational programs based on our community needs, values, and expectations; and

WHEREAS, upon election, Trustees take the oath of office in which they solemnly swear to faithfully execute the duties of Trustee and will preserve, protect, and defend the Constitution and laws of the United States and of Texas; and

WHEREAS, the Texas Education Code mandates that Trustees oversee the management of the District and ensure that the Superintendent implements and monitors plans, procedures, programs, and systems to achieve appropriate, clearly defined, and desired results in the major areas of district operations; and

WHEREAS, according to the Texas Education Code, the Board of Trustees may act only by majority vote of the members present at a meeting held in compliance with Chapter 551 of the Texas Government Code, at which a quorum is present and voting; and

WHEREAS, the Texas Education Code mandates that Trustees complete all continuing education requirements, including evaluating student academic performance, identifying and reporting abuse, and school safety; and

WHEREAS, District Policy BBD mandates that Trustees, not later than the 90th day after taking the oath of office, shall complete training of not less than one and not more than two hours regarding the responsibilities of the board and its members under the Texas Open Meetings Act and the Texas Public Information Act; and

WHEREAS, District Policy BBD mandates that Trustees shall complete all training required by the State Board of Education; and

WHEREAS, District Policy BBD mandates that Trustees shall complete local district orientation, Texas Education Code orientation, legislative update orientation, and engage in team building with the Superintendent; and

WHEREAS, Trustee Shirley Ibarra and former Secretary of the Board of Trustees, has failed to attend 74% of the regular meetings, special meetings, Board training sessions, and workshops called by the Board of Trustees since August 9, 2023; and

WHEREAS, Trustee Shirley Ibarra and former Secretary of the Board of Trustees, has failed to complete minimum training requirements in the areas of cybersecurity, team building, and additional training requirements; and

WHEREAS, because of chronic absences, Trustee Shirley Ibarra has been and continues to be in serious violation of Texas state law and District policy; and

WHEREAS, the Texas Education Agency ("TEA") has specifically identified Trustee Shirley Ibarra's failure to execute the duties of Trustee as a serious obstacle to effective Board governance; and

WHEREAS, Texas Local Government Code §87.011 and District policy BBC defines "incompetency" as the gross ignorance of official duties; gross carelessness in the discharge of those duties; or unfitness or inability to promptly and properly discharge official duties because of a serious physical or mental defect that did not exist at the time of the officer's election; and

WHEREAS, Texas Local Government Code §87.011 and District policy BBC defines "official misconduct" as intentional, unlawful behavior relating to the official duties by an officer entrusted with the administration of justice or the execution of the law including an intentional or corrupt failure, refusal, or neglect of an officer to perform a duty imposed on the officer by law; and

WHEREAS, Texas Local Government Code §87.012, §87.013, and District policy BBC state that a Trustee is subject to removal from office for incompetency or official misconduct; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of the District hereby deems Trustee Shirley Ibarra as incompetent, grossly ignorant, grossly careless, and unfit for office, as defined by the Texas Local Government Code; and

BE IT FURTHER RESOLVED that the Board of Trustees does hereby publicly censure Trustee Shirley Ibarra for incompetency and official misconduct for her intentional, unlawful dereliction of duty, and for her intentional failure or refusal to perform the duties of Trustee; and **BE IT FURTHE RESOLVED** that the Board of Trustees of the District does hereby publicly censure Trustee Shirley Ibarra for violating her oath of office by failing to execute the duties of her office, betraying the trust of the constituents of District Four, and failing to serve as their elected representative; and

BE IT FURTHER RESOLVED that the Board of Trustees does hereby demand that Trustee Shirley Ibarra immediately tender her written resignation from the Board of Trustees to allow another public servant to serve the constituents of District Four; and

BE IT FURTHER RESOLVED that the Board of Trustees direct legal counsel to file a formal complaint on behalf of the Board of Trustees with the Office of the Attorney General and the Bexar County District Attorney's Office pursuant to Texas Government Code Chapter 87; and

BE IT FURTHER RESOLVED that this formal censure repudiating Trustee Shirley Ibarra's behavior and actions described herein will be read into the official minutes of the District's proceedings, as required by Board Operating Procedure 8.2.

If, during the course of the meeting, any discussion of any item listed on the agenda should be held in Closed Meeting, the Board will

convene in such Closed Meeting in accordance with Texas Government Code Sections 551.001 -551.088. The Board members may take action in the open portion of the meeting on items discussed in the Closed Meeting but no action will be taken in closed session.
