Presentations/ Recognitions Each year the Texas Association of School Boards (TASB) honors businesses and organizations for their support and exceptional advocacy of local schools. This state-wide honor, as part of "Stand Up for Texas Public Schools," recognizes local businesses and community organizations who partner with districts, making a difference in the lives of local public-school students.

For more than a decade, the University of North Texas Athletics has hosted more than 20,000 Denton ISD students during various sporting events and touched the lives of even more students through philanthropic efforts. Annually, fourth and fifth graders from local schools are given the opportunity to attend a basketball game at UNT with many experiencing a college athletic event for the first time. Denton ISD students perform the national anthem, participate in halftime games and often get the opportunity to interact with student-athletes from other sports.

In addition, UNT Athletics, in partnership with Conference USA and Michaels, has awarded \$40,000 over four years in gift cards to our fine arts teachers on all grade levels. For many of our teachers, this gift doubles the size of their annual budget and allows them to provide additional supplies directly benefit our students.

Each spring, UNT Athletics partners with our middle schools for the National Girls and Women in Sports Day, bringing female middle school athletes to UNT for workshops and lessons from current college student-athletes. These, and many others, the reason why UNT Athletics was chosen for the December Community Spotlight.

Two Denton ISD graduates and local restaurant owners, John Williams (Oak Street) and Corey Bobbitt (Komodo Loco), could not stand the thought of students not being able to pay off their school lunch balances, risking a student's ability to select their meal of choice. In 2018, they created a one-day food festival in an effort to solve the shortage. An afternoon of fun and \$15 tickets has now reaped almost \$8,100 which is now clearing student's balances and helping hundreds of students across the district.

In November Kelley McGee, art teacher at Borman Elementary, was named the Texas Art Education Association's Elementary Art Teacher of the Year. The state award is given to an educator who has significantly contributed to the association and to art education on the local, state and national levels. The District is proud to feature her in this month's Board Spotlight.

1st Open Forum

Willie Hudspeth addressed the Board and was pleased with the pledge students, and Kelly McGee's honor. He also addressed the Board about the Gas wells as well as there has not been an African American head football coach in Denton ISD.

Claudette Fette addressed the Board about trees, a Live Oak trees, a Red Oak tree that was cut down at Woodrow Wilson for parking. She was devastated to see these trees cut down.

Susan Lender provided the Board with written information. She prefers Woodrow Wilson teachers to continue to park on Emerson and to not use Avondale Park as a parking lot.

Discussion of Annual Safety & Security Update Dr. Jeff Russell, Area Superintendent presented a review and update of district safety and security procedures and their alignment with Senate Bill 11. Since 2005, all Denton ISD buildings have been on a rotation for safety audits. The audits were developed by the Texas School Safety Center. As a biproduct of these audits, improvements have been made in the overall safety of campuses and the district. Improvements due to the District Audits are:

- Improved campus Emergency Operation Plans
- Increased interaction with local law enforcement
- Improved campus visitor procedures
- Numbering of all exterior doors inside and outside
- Card access systems at all campuses
- Increased camera coverage

- Increased secured entrances to early childhood, elementary, middle school and high school campuses
- Increased emphasis on lockdown drills; standardizing procedure district-wide

## Discussion of Projector Refresh

Ross Garrison, Director of Instructional Technology provided the Board of Trustees the process the Denton ISD Classroom Display and A/V Refresh committee used to evaluate various solutions in pursuit of fulfilling the projector initiative within the 2018 bond package.

The Denton ISD Classroom Display and A/V Refresh committee shared findings from pilot classrooms that informed the committee's decisions to move forward with a recommendation to purchase interactive panels, rather than interactive projectors. They also compared the features and functionality of interactive panels and interactive projectors. The committee purchasing Promethean ActivPanels for the targeted instructional spaces and some additional non-interactive Epson projectors that will go in spaces where an Interactive panel cannot be hung.

Garry Ryan, Executive Manager of Construction, Planning & Growth provided the Board of Trustees with updated photos from the various construction projects. Garry presented Woodrow Wilson Elementary, Strickland Middle School and DHS replacement campus progress. At Strickland they have completed the underground utility work including water, sewer and gas lines. They have also completed the paving for the East fire lane and started the exterior ICF walls for the storm shelter and classroom wing as well as the CMU elevator shaft wall for the new elevator. Upcoming projects will be to complete the exterior ICF walls for the storm shelter and classroom wing and the elevator shaft walls. Steel erection for

the storm shelter and classroom wing will begin as well as pouring concrete for the level 2 storm shelter roof, window installation and interior framing for the storm shelter and classroom wing.

Denton ISD Growth Report 3<sup>rd</sup> Quarter Rocky Gardner, Templeton Demographics presented the 3<sup>rd</sup> Quarter Growth Report. Denton has a 2.1 % rate of unemployment with a job growth of 2.7% and annual home starts with 33,675. Since 2010, the average new home price in Denton ISD has increased by \$107,838, or 51%. The average existing home price within the district has increased by 62%, or roughly \$109,808 since 2010. Denton ISD started more than 742 homes in 3Q19, the most starts in the past ten years and the district closed approx. 1,770 homes so far in 2019, putting them on pace to close more than 2,300 homes by the end of the year. The district has more than 4,500 lots available to build on within Denton ISD there are more than 30,000 planned future lots. Within Denton ISD there are roughly 4,180 future multi-family units in the planning stages. Denton ISD is expected to enroll nearly 34,200 students by 2024-25 and more than 37,800 students by 2029-30.

2019-2020 2<sup>nd</sup> Period Attendance Report Angela Ricks, Director of Support Services provided this report to provide campus and district ADA percentages for the 2<sup>nd</sup> Reporting Period of the 2019-2020 school year (September 23, 2019 through November 1, 2019) and to compare this data to prior years. There are 28 instructional days in this 2<sup>nd</sup> Reporting Period. The district ADA % for 2019-2020 Reporting Period 2 is 96.51%, this is a very slight decrease from last school year when the ADA % was 96.64%. Adkins had the highest ADA percentage for elementary campuses in Denton ISD at 97.65%. Harpool had the highest ADA percentage for middle school campuses in Denton ISD at 97.66%. Guyer had the highest ADA percentage for high school campuses in Denton ISD at 97.0%.
