Mrs. Gautille and Mrs. Warner reported that they had recently attended the Legislative Advisory Council meeting in Austin, Texas on Saturday, May 22, 2004. The 105 member council, comprised of board representatives from regional service centers across the state, helps the TASB design its legislative agenda and set priorities and positions.

Dr. Mike Arthur announced that last week the Education Foundation went on "prize-patrol" and awarded approximately \$26,000 in grants to all three CISD middle schools and numerous elementary schools.
