Pursuant to a resolution adopted by each of the following school districts:

School District, Turtle Lake School District, School District of Prairie Farm, Clayton
School District

Said school districts hereby mutually agree, pursuant to Section 66.0301 of the Wisconsin Statutes, to the following conditions:

- That said above parties agree and contract for the cooperation of <u>North Star</u> <u>Academy Charter School</u> as hereinafter set forth;
- 2. That the <u>School District of Cameron</u> is to be the operator and fiscal agent of North Star Academy Charter School program;
- That the fiscal agent district will include all program expenditures and receipts in Fund 90 of the Wisconsin Elementary and Secondary School Accounting System (WUFAR).

(Fiscal Agent Requirements)

- 4. That student membership for state aid purposes be counted by the district of residence;
- 5. That the proration of costs to each participating district be determined prior to June 30, annually, on the basis of pupil participation for each school district and as established by the governance board of North Star Academy;
- 6. That upon signing the initial Section 66.0301 agreement, the above listed school districts shall participate in the cooperative program through the 2029-2030 school year at a level equivalent to the 2025-2026 school year;
- 7. That transportation, if required, is to be furnished by the district of residence and the special transportation aid shall also be claimed by the district of residence;
- That the program share cost, including payment schedule (Appendix A) for this cooperative, shall be approved in advance of contract signing by the governance board of North Star Academy;
- 9. That variations from the budget will require prior approval of the governance board of North Star Academy hereto;

- 10. That the fiscal agent agrees to file a plan of service and the required financial reports with the Wisconsin Department of Public Instruction;
- 11. That each participating district agrees to correlate its calendar with the host school's calendar in the program area covered by this contract;
- 12. That the Cooperative Program Fiscal Agent Policy (Appendix B) attached hereto and incorporated herein by reference includes the plan for operation and plan of payments to said operator or fiscal agent by each school district:
