Background:



- SB 569 created new virtual options under TEC 30(B).
- The district has been discussing and exploring the different options afforded by TEC 30(B).
- Neighboring districts are beginning to announce new virtual and hybrid options for the 2026-27 school year.
- We have had steadily growing demand for online courses in LISD over the past decade. We want our students to continue to choose LISD!

Historical Perspective



- What LISD has historically offered through Virtual Learning Academy:
 - High school students can take up to 3 credits of their schedule as virtual courses. Virtual class cannot be scheduled 2nd period.
 - Students are limited to no more than 2 virtual credits in a single semester.
 - Our course catalog focuses on junior and senior-level offerings with additional courses available from non-LISD providers through the Texas Virtual Schools Network.
 - Record demand has required us to close many courses as full in recent terms.

Online Course Offerings



- LISD currently has 40 courses in our district-created virtual course catalog that operates on the Texas Virtual Schools Network. These courses are available to LISD students and students across the State of Texas.
- RFP issued November 7, 2025 to consider companies to help expand LISD online course offerings. Recommendation will be coming forward to the Board in February.
