Presented for the governing board's approval are the revised high school course fees for selected Fine Arts and Career and Technical Education (CTE) courses for the 2024-2025 school year. The revisions appear in red font on the document titled *2024-2025 High School Course Fees and Extracurricular Performing Arts Fees*.

After your approval of the 2024-2025 High School Course Fees and Extracurricular Performing Arts Fees on June 25, 2024, there were some additional changes and corrections that were necessary to ensure that all fees and titles were aligned with the Course Guide.

A request was submitted to increase the fee for *Intermediate Theatre Production* (from \$40 to \$50) due to increased costs for make-up. This increase brings the fee for *Intermediate Theatre Production* into alignment with the current fee for *Advanced Theatre Production 1 and 2*.

After a thorough review of the *Catalina Foothills High School Course Guide* and the *2024-2025 High School Course Fees and Extracurricular Performing Arts Fees* document, the following discrepancies were found:

- On the line for *Drumline / Percussion*, the word “Techniques” was removed to reflect the course name as presented in the high school *Course Guide*.
- Under *Symphonic Strings*, the line that lists the \$95 instrument rental fee was inadvertently entered in place of the \$25 co-curricular fee.
- Under *Beginning Steel Drums-Semester* and *Beginning Steel Drums-Year*, the words “Semester” and “Year” were removed from the column titled *CFHS Proposed Course Fee Description* because the name of each of these courses already references the tuning fees for one semester versus a full year.
- The course name for *Change of Pace* was revised to align with the choir courses listed in this section and also to reflect the name of the course as it is presented in the high school *Course Guide* (i.e., *Choir: Change of Pace*).
- The fees for *Advanced Theatre Production Internship* (\$10 co-curricular, \$50 lab fee) were inadvertently omitted.
- Lines were added to include the fees for both *Advanced Theatre Arts-Semester* and *Advanced Theatre Arts-Year*. This addition does not represent any change in fees; it simply separates the fees for one-semester and full-year courses. The same change was made for *Advanced Theatre Arts: Acting Ensemble-Semester* and *Advanced Theatre Arts: Acting Ensemble-Year*.
- Under the column titled *CFHS Current Course Fee Description* (for *Film and TV*, *Studio Art*, and *Ceramics and Sculpture*), the word “Fee” was replaced with “Lab Fee.”
- *Ceramics 1* and *Ceramics 2* was changed to *Ceramics & Sculpture 1* and *Ceramics and Sculpture 2* to align with the course names as presented in the high school *Course Guide*.

The changes related to fees in the bulleted items above have been listed in InTouch in previous years and are included in the course guide.
