## SECOND EXTENSION OF AGREEMENT TO PERFORM TRANSPORTATION SERVICES BETWEEN INDEPENDENT SCHOOL DISTRICT 14, FRIDLEY PUBLIC SCHOOLS AND FIRST STUDENT, INC.

**THIS AMENDMENT** is made and entered into as of the day of , 2025 by and between Independent School District 14, Fridley Public Schools with principle offices at 6000 West Moore Lake Drive, Fridley, Minnesota 55432 ("District") and First Student, Inc. with its national headquarters at 191 Rosa Parks Street, 8<sup>th</sup> Floor, Cincinnati, OH 45202 and local business offices for purposes of this Agreement located at 11911 Champlin Drive, Champlin Minnesota 55316 ("Bus Company" and, collectively, the "Parties").

**WHEREAS,** the Parties entered into that certain Agreement to Perform Transportation Services dated April 18, 2022, and First Extension of Agreement dated May 16, 2024 (hereinafter the "Agreement"); and

**WHEREAS**, the Parties desire to further extend the term of the Agreement;

NOW, THEREFORE, the Parties mutually agree as follows:

- 1. <u>TERM.</u> The term of the Agreement shall extend for three (3) additional years commencing July 1, 2025 and continuing through June 30, 2028.
- 2. <u>AGE OF VEHICLES.</u> The average age of buses operating in the District shall be no more than 8 years old throughout the duration of the extended term.
- 3. <u>COMPENSATION.</u> Commencing July 1, 2025, the rates of compensation payable hereunder during the ensuing Contract Years 2025-26, 2026-27 and 2027-28 shall be as listed in Appendix A which is attached hereto and made a part hereof and are based on current number of routes in the 2024-25 Contract Year.
- **4. NOTICE TO PARTIES.** All notices to be given by the Parties to this Agreement shall be in writing and serviced by depositing same in the United States Mail, certified mail.
