I. SUPERINTENDENT'S REPORT

- A. Recognitions: Mr. Smith and Mrs. Hill were both recognized for their achievements.

- B. <u>Board Meeting Dates for the 2011-2012 School Year:</u> The list of meeting dates for 2011-12 was provided.
- C. <u>Legislative Update:</u> Supt. Glaes referred to discussions with Margaret O'Brien and Tonya Shuitmaker regarding ways the Legislature can help school districts. Board members were asked to approve a resolution later on the agenda recommending legislative action to help schools.

II. REPORTS AND PUBLIC INQUIRY

A. Financial Report - Steve Goss:

- 1. <u>May Budget Progress Report:</u> Asst. Supt. Goss reviewed the budget progress report for May 2011 showing total revenues of \$15,992,071; total expenditures of \$17,008,576; and deficiency of revenues over expenditures of -\$1,016,505.
- 2. Resolutions to Amend the 2010-11 Budgets and Adopt the 2011-12 Budgets for the Following Funds: General Fund, School Service Funds, Debt Retirement Funds, and Building and Site Fund: Asst. Supt. Goss reviewed the 2010-11 amendments and the 2011-12 budgets. Based on the proposed amendment, the General Fund balance is projected to increase by approximately \$265,000 to just under \$2.3 million or 10.7% of the current year budget. Three budget goals are to preserve programs and services to students, minimize negative impact to our staff, and operate in a fiscally responsible manner within the funding provided.
- B. <u>ANNUAL PUBLIC HEARING</u> to Consider the District's 2011-12 Budgets and Proposed Property Tax Millage Rate: President Knowles opened the hearing to the public at 8:33 p.m. No one wished to address the Board, so the hearing was closed.
- C. Food Service Update Maureen Ouvry:
 - 1. <u>Dairy and Bakery Bid Report:</u> Mrs. Ouvry asked that the Board approve bids from Prairie Farms and Aunt Millie's for the 2011-12 school year.
 - 2. <u>School Lunch Price Increase:</u> The Federal Government had mandated that school lunch prices be raised until the district average is \$2.46. Mrs. Ouvry requested approval to raise prices to \$2.25 for 2011-12 with additional increases each year until the district average is \$2.46. Surveys show that our District prices are in line with other districts.

3. <u>Summer Food Service Program:</u> Mrs. Ouvry stated that Food Service will be offering summer feeding programs at two sites and two different formats. Portage Terrace will be a USDA site, with volunteers from Lake Center Bible Church on site to help distribute food and monitor distribution. The Village Market Place will be a community support site.

D. Instructional Report - Charles Glaes:

- 1. Annual Curriculum/Program Proposals:
 - a. <u>High School Social Studies AP American History Course:</u> Rob Johnson explained that this will be a new Advanced Placement course offering for the High School and requested approval later on the agenda for the curriculum and textbooks.
