Procurement Recommendation:

The Administration recommends approval of and Amendment to the Guaranteed Maximum Price (GMP) for Arndt Elementary Classroom Wing Addition in the amount of \$42,390.66. This amendment is a result of modifications to the scope of work related to additional storm drainage utilities that need to be built as a result of the classroom wing addition.

When the GMP was submitted, the specifications did not require underground storm drainage systems, but the final plans and specifications developed by the Architect and Civil Engineer, require additional improvements to the existing campus to ensure adequate functionality and compliance with ADA regulations. (Please see attached exhibit with site plan and cost proposal breakdown information).

Rationale:

Staff has complied with all applicable federal, state and local purchasing policies and procedures in obtaining pricing information for the items listed above.

INVOLVING THE
ARNDT ELEMENTARY SCHOOL CLASSROOM WING ADDITION
AND PARKING LOT EXPANSION**

This First Amendment to the Construction Manager at Risk Agreement (this "Amendment") is made by and between the **United Independent School District** (the "Owner") and **Leyendecker Construction of Texas, Inc.** (the "CM") regarding the construction involving Arndt Elementary School

RECITALS

WHEREAS, the Owner and CM entered into that Certain Construction Manager at Risk Agreement ("AIA A133-2009 Standard Form of Agreement between Owner and Construction Manager as Constructor where the basis of Payment is the Cost of Work Plus a Fee with a Guaranteed Maximum Price" also known as the "Agreement or Contract") for the construction of a Classroom Wing Addition and Parking Lot Expansion at Arndt Elementary School; and

WHEREAS, Article 5 section 5.3.1. of the Agreement allows the Owner, without invalidating the Contract, order changes in the Work within the general scope of the Contract consisting of additions, deletions or other revisions, and

WHEREAS, Article 5, section 5.3.2 of the Agreement allows for adjustments to the Guaranteed Maximum Price on account of changes in the Work subsequent to the execution of the Guaranteed Maximum Price; and

WHEREAS, The Owner and CM desire to enter into this Amendment to amend the Agreement which reflects a change and additions in the scope of the Work

AGREEMENT

1. Article 5 §5.3.1. Owner is seeking to modify the Scope of Work related to additional storm drainage utilities that are needed to be built as a result of the classroom wing addition which is to be considered as an addition to the general scope of Work under the Contract. The site plan for the proposed storm drain is attached and incorporated herein as **Exhibit "A"**

2. Article 5 § 5.3.2. CM has submitted a Guaranteed Maximum Price for the construction of the storm drain. The Guaranteed Maximum Price for the construction of the storm shall not exceed FORTY-TWO THOUSAND THREE HUNDRED NINETY DOLLARS SIXTY-SIX CENTS (\$42,390.66) as set out on page 2 of **Exhibit "B"** which is attached and incorporated herein.

3. Article A.1 §1.1.1. The Guaranteed Maximum Price set out under Article A.1 §A.1.1.1 shall be increased by an amount not to exceed FORTY-TWO THOUSAND THREE HUNDRED NINETY DOLLARS SIXTY-SIX CENTS (\$42,390.66) to construct the storm drain.

4. Article A.1 §1.1.2. **Exhibit "B"** to this amendment is to be included as part of the itemized statement set out under Article A.1 §1.1.2.

Miscellaneous

a. **Capitalized Terms.** Capitalized terms not defined herein shall have the same meaning assigned to such terms in the Agreement.

b. **Amendment to Agreement.** The Owner and the CM acknowledge and agree that the Amendment has not been amended or modified in any respect, other than by this Amendment. The term "Agreement" shall mean the Agreement as amended by this Amendment unless the context requires otherwise.

c. **Full Force and Effect.** Except as expressly amended hereby, all other items and provisions of the Agreement remain unchanged and continue in full force and effect.

d. **Conflicts.** The terms of this Agreement shall control over any conflicts between the terms of the Agreement and the terms of this Amendment.

e. **Counterparts.** This Amendment may be executed by the parties in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts shall together constitute but one of the same agreement. All signatures need to be on the same counterpart.



OVERALL SITE PLAN






SITE PLAN




