

AMENDMENT NO. 1

The Affiliation Agreement between **Amphitheater Unified Public Schools District No. 10 (“Affiliate”)** and the **Arizona Board of Regents on behalf of The University of Arizona College of Nursing (“University”)** dated October 1, 2011, for coordinated clinical training of trainees (“Program Participants”), from the University, is hereby amended as follows effective May 1, 2013:

- I. It is agreed to by the Parties that this Affiliation Agreement shall be between **Amphitheater Unified Public Schools District No. 10, 701 W. Wetmore Road, Tucson, Arizona 85705**, and the **Arizona Board of Regents on behalf of the University of Arizona, (College of Nursing and the College of Sciences, Department of Speech, Language and Hearing Sciences)**.

- II. **Section 5, Accreditation Compliance, shall be deleted in its entirety and replaced with the following:**

“Accreditation Compliance. This agreement covers the University of Arizona College of Nursing and the College of Science. The accreditation bodies (“Accreditation Agencies”) responsible for the accreditation of the academic programs within each of these two colleges, are as follows:

- College of Nursing – Commission on Collegiate Nursing Education (CCNE)
- College of Science – American Speech-Language-Hearing Association (ASHA)
For Audiology and Speech-Language Pathology Students “

- III. **Section 6, paragraph A shall be deleted in its entirety and replaced with the following:**

“Maintain accreditation by the nationally recognized accreditation entities identified in Section 5.”

- IV. **Section 6, paragraph B shall be deleted in its entirety and replaced with the following:**

“Provide qualified faculty and a structured educational experience to Program Participants in accordance with the accreditation standards of the applicable Accreditation Agency identified in Section 5.”

- V. **Section 6, paragraph C shall be deleted in its entirety and replaced with the following:**

“Operate and manage the Colleges and their associated health sciences student and residency programs in accordance with applicable accreditation guidelines and standards.”

- VI. **Section 6, paragraph D shall be deleted in its entirety and replaced with the following:**

“Designate a member of the University’s faculty to arrange for supervision, provide coordination, oversight and direction of Program Participant training activities and assignments while at Affiliate.”

VII. **Section 7, paragraph J shall be deleted in its entirety and replaced with the following:**

"In accordance with accreditation guidelines by the appropriate Accreditation Agency identified in Section 5, Affiliate will comply with, at a minimum, the following requirements:

- i. Ensure responsibility for the control and operation of Affiliate's facilities and its programs.
- ii. Cooperate with the University and acknowledge the University's sole authority with respect to academic programs.
- iii. Use its best efforts to ensure that its environment promotes the development of appropriate professional attributes in the Program Participants assigned thereto.
- iv. Provide the clinical facilities and equipment reasonably necessary for the Program Participants' clinical training (as appropriate to include but not be limited to: on-call rooms and meals, study space, cafeteria, parking, etc.) and allow reasonable use of medical libraries, classrooms and conference rooms, as mutually agreed."

All other terms and conditions of the Agreement shall remain in effect.
