MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN BROWNSVILLE INDEPENDENT SCHOOL DISTRICT AND CITY OF NEW BRAUNFELS POLICE DEPARTMENT

I. PURPOSE

This Memorandum of Understanding (MOU) is entered into by and between the Brownsville Independent School District ("School District") and the City of New Braunfels Police Department ("New Braunfels PD") to establish the terms and conditions under which the Brownsville Independent School District will purchase police vehicles from the City of New Braunfels Police Department for the Brownsville Independent School District's Police & Security Services Department ("BISD Police PD").

II. PARTIES

III. SCOPE OF AGREEMENT

The City of New Braunfels Police Department agrees to sell, and the Brownsville Independent School District agrees to purchase, police vehicles currently owned by the New Braunfels Police Department for use within the School District's Police Department. The vehicles are to be used for school safety and law enforcement purposes in accordance with applicable laws and regulations.

- Any defects or issues must be reported within [10] days of delivery.

VIII. LIABILITY AND INSURANCE

- The School District assumes all liability for the vehicles upon acceptance.
- The School District agrees to maintain appropriate insurance coverage for the vehicles.

IX. TERM

This MOU shall commence on the date signed by both parties and shall remain in effect until all obligations have been fulfilled or terminated by mutual agreement.

X. AMENDMENTS

Any amendments or modifications to this MOU must be made in writing and signed by authorized representatives of both parties.

XI. TERMINATION

This MOU may be terminated by either party upon [number] days written notice to the other party.

XII. GENERAL PROVISIONS

• This MOU does not create a partnership, joint venture, or agency relationship.

• Both parties shall comply with all applicable laws, regulations, and policies.

XIII. SIGNATURES
