

**AMENDMENT TO EXTENSION OF PUPIL
TRANSPORTATION SERVICES AGREEMENT**

THIS AMENDMENT entered into as of the 5th day of July 2023 is made by and between Roselle School District #12 with principle offices at 100 E Walnut St., Roselle, Illinois 60172, hereinafter called "DISTRICT" and FIRST STUDENT, INC. (formerly LAIDLAW TRANSIT, INC.) with its local operating address at 1500 Wright Blvd, Schaumburg, Illinois 60193, and its national headquarters at 600 Vine Street, Suite 1400, Cincinnati, Ohio 45202, hereinafter called "CONTRACTOR".

WHEREAS, the parties entered into that certain Pupil Transportation Services Agreement described herein; and

WHEREAS, the parties desire to further extend the term of the Agreement and amend certain portions thereof;

NOW, THEREFORE, the parties mutually agree as follows:

- 1. TERM:** The term of the Agreement shall extend for one (1) additional year commencing July 1, 2023 and continuing through June 30, 2024; thereafter this agreement may be extended on a year-to-year basis by mutual agreement of the parties, subject to the operation of ILL.Rev.Stat.Ch.105, Sec.5/29-6.1.
- 2. COMPENSATION:** Commencing July 1, 2023, the rates of compensation payable hereunder during the ensuing Contract Year shall be set forth in Exhibit "A" and are based on current number of routes.
- 3. FUEL ESCALATOR:** Fuel peg is \$3.00 per gallon. Each month, included with regular billing, increases or decreases in fuel cost will be reflected as charge or credit as defined in original bid specifications.
- 4. ASSIGNMENT:** Notwithstanding any provision to the contrary in the Agreement, the CONTRACTOR may assign this Agreement if the assignment is made to a parent, subsidiary, related or affiliated company.
- 5. TERMINATION:** Either party may terminate all or part of this agreement for convenience upon thirty (30) days' written notice to the non-terminating party.
- 6. NOTICE TO PARTIES** All notices to be given by the parties to this Agreement shall be in writing and serviced by depositing same in the United States Mail, certified mail.
