I. SUPERINTENDENT'S REPORT

A. Recognitions

Supt. O'Neill announced that Tobey was named a 2023 Honorable Mention School of Character by www.character.org.

B. Legislative Update

Supt. O'Neill gave an update on the Read by Grade 3 discussion at the state level. Governor Whitmer's budget proposal for education is very favorable and includes a 5% increase to the foundation. There is a proposed increase of \$80 million for special education, english learners, and teacher recruitment and retention. Pre-K for all 4 year olds is also included. The District is eagerly awaiting the budget from the House and the Senate. Supt. O'Neill believes this proposal is a great start and is supported by many education associations.

Supt. O'Neill directed the board to the listing of important upcoming dates included in the packet highlighting Middle School and High School band concerts, elementary concerts, Bus Driver Appreciation Day and mid-winter break on February 23.

Asst. Supt. Goss presented the budget progress report for month ending January 31, 2023 showing total revenues of \$13,463,242; total expenditures of \$15,405,455 and deficiency of revenues over expenditures of \$(1,942,213).

Asst. Supt. Goss gave an update on the District's investment portfolio.

C. Section 98b Progress Report - Gail Van Daff

Curriculum Director, Gail Van Daff, presented the Section 98b progress report and the data in a narrative format. The District is still responding to the loss of education time due to COVID.

D. Vicksburg Middle School Annual Report - Allison Dygert

Principal Dygert and Asst. Principal Werkema presented the Vicksburg Middle School Annual Report which included highlights of student activities, student data review, recognitions, and staff professional development.
