Presentations/ Recognitions Denton ISD high schools recently produced nine students that qualified or finished as alternates for the UIL Academic State Meet held at the University of Texas at Austin in May. Each of these students was among the top three finishers in their individual event or top two finishers in their team event at the Class 6A and Class 5A UIL regional academic meets. Guyer High's cast and crew earned a fourth-place finish at the state one act play competition.

Carrie Martin, a second-grade teacher at Evers Park Elementary, was recently named the national Teacher of the Year by Barnes & Noble Booksellers. Mrs. Martin claimed the award on the basis of a letter, written by Ti Anna Bridges-Reed, explaining how she made an impact on her education. Ti Anna, a member of Ryan High School's Class of 2016, credited Mrs. Martin with helping her overcome dyslexia and supporting her throughout her educational career in Denton ISD.

The National School Public Relations Association recently selected Dr. Jamie Wilson, Denton ISD superintendent of schools, as one of 24 education leaders for outstanding community engagement and communication practices. Dr. Wilson is the lone honoree from Texas and the only representative from the organization's South Central Region of the United States, which encompasses seven states, named as a 2015-16 Superintendent to Watch.

Public Hearing for 2016-2017 Budget & Tax Rate

Public Hearing opened at 6:22 pm.

Mrs. Monschke, assistant superintendent of business and operations, reviewed the plan for the 2016-17 school year budget with members of the public who were present. This year's budget process has been focused on addressing a projected increase in student enrollment of 1.27 percent or 342.5 students and maintain current programs.

The district is projected to withstand a decrease in state funding of approximately \$5.9 million as compared to the prior year's adopted budget. Property tax collections are expected to increase by \$8,813,949 with the Maintenance and Operations Tax Rate remaining at \$1.04.

The presentation will highlight conference participant reflections and the exceptional "assessment *for* learning" work our teachers are implementing in Denton ISD classrooms in support of student learning and student achievement. Denton ISD Assessment for Learning Conference, in its inaugural year, had a total of 588 educators in attendance for two days at Guyer High School. Participants had the opportunity to learn alongside authors/researchers/experts/colleagues who are all implementing this work.

Discussion of Employee Health Insurance/Benefits Karen Almon, Director of Risk Management provided a brief update of the changes for 2016-2017 employee benefits.

Active Care 1-HD, the district's most used plan, saw no rate increase but did see an increase of \$100 in out-of-pocket expenses, from \$6,300 to \$6,400. As a result of the district's contribution, the cost of the plan per employee

decreased from \$90 to \$81. Under the plan, prescription co-pays increased from \$25 to \$35 with preferred brands also seeing an increase from \$50 to \$60.
