ADDENDUM TO INTERLOCAL AGREEMENT FOR SCHOOL CROSSING GUARDS

This Addendum to Interlocal Agreement for School Crossing Guards ("Addendum") is entered into by and between Ector County Independent School District, ("District"), and City of Odessa, a Texas home-rule municipal corporation, ("City"). District and City are each a Party and are collectively referred to as the "Parties".

WHEREAS, the Parties entered into the Interlocal Agreement for School Crossing Guards (the "Agreement") on August 13, 2019, wherein City and District shall fund, administer and operate a program to provide for school crossing guards for public schools of the District within the city limits pursuant to the terms and conditions contained herein; and

WHEREAS, the Parties wish to modify the Agreement to include an additional funding term for the 2021-2022 school year;

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and agreements of the parties hereto, City and District do mutually agree to following:

ADDENDUM

1. This Addendum becomes effective on the last date of execution hereof by all Parties.

2. This Addendum is subject to the approval of the City Council of Odessa, Texas.

3. Section IV. Funding for School Crossing Guards of the Agreement is hereby modified by adding the following:

"3. For the term Aug. 2021-Sept. 30, 2022 City will cover 100% of the cost of one (1) additional crossing guard not to exceed 540 hours for a total of \$11,113.20.

4. The terms and conditions of this Addendum are hereby incorporated into and shall modify, amend and supplement the Agreement.

5. Except as specifically set forth in this Addendum, all other provisions of the Agreemnt are unaffected and shall continue in full force and effect in accordance with its terms.
