Based on our conversations with Mr. Bear and working on the Corporation's multi-year roof management plan, we understand that **Lafayette School Corporation's** 2018 CPF budget will have funds set aside for roof work at various locations. **the etica group, inc.** (**etica**), is pleased to submit this proposal for Roof Consulting services for the above referenced project for your review and acceptance.

1.0 Description of Project

The 2018 Roof Work has identified work at four (4) of the Corporation's facilities. The roof work would consist of removing the existing identified roof systems and replacing them with a new modified roof system. The following is a preliminary project structure for the 2018 CPF Roof Work:

2.0 Scope of Work

The scope of work for this project is indicated as follows:



Field Investigation Services that will result in:

- Coring the existing roof assemblies to determine existing conditions
- Provide sampling of existing membranes and flashing for asbestoscontaining analysis and assessment for friability if asbestos is present
- Evaluate the existing structure for loading capacity
- Develop as-built details of current conditions (base flashing, perimeter edge conditions, etc)
- Measure and locate all roof top equipment
- Evaluate the existing roof drainage systems

Design Services that will result in a set of contract documents (drawings and specifications) to be used for bidding and construction services

- Develop roof plans showing new work
- Develop a taper insulation design (if required) for drainage
- Design new roof system that would include a minimum R value of R-24
- Take as built details of existing conditions and develop details for the new work
- Conduct a pre-bid meeting with prospective bidders and answer questions throughout the bidding process
- Attend bidding opening and provide a recommendation for award of work
- Attend school board meeting when the bids are present to answer questions

Construction Administration Services that will result in:

- Request pre-contractual documents from the successful contractor and review
- Review all submitted shop drawings and product literature
- Conduct a pre-construction meeting on site prior to the start of work with the Owner and contractor(s)
- Provide minimum 1 field visit a week during the construction period (more field visit may be required based on contractor and Owners request, additional visit will be billed on a straight hourly base)
- Conduct bi-weekly construction progress meetings (if required by Owner)
- Conduct a final inspection of work and issue a written punch list of work that needs completed or corrected
- Review all project close-out documents submitted by Contractor
