The regular meeting of the Board of Trustees of the Aledo Independent School District was held on Monday, November 12, 2012, beginning at 7:00 P.M. in the Aledo I.S.D. Board Room with the following members present: President Bobby J Rigues, Vice President Jay Stringer, Secretary Johnny Campbell, Steve Bartley, and Dr. David Tillman.

AGENDA

President Bobby J Rigues called the meeting to order at 7:00 P.M.

President Bobby J Rigues determined a quorum was present at this time.

Jason Beaty, Principal of McCall Elementary, and students led everyone in the pledges of allegiance to the United States and Texas flags and sang selections from their 4th grade musical.

Mrs. Lynn McKinney, Deputy Superintendent, and Mr. Jay Stringer, Board Vice President, presented the following commendations:

Joey Paul, Jake Albin and the Band Leadership Team received recognition for the many Band Achievements this

year.

Jessica McCane, teacher at Aledo High School, received the Jack Harvey Award.

Dillion Savage was recognized for placing fourth chair in the TMEA All Region Choir.

Michaela Owen was presented a \$50.00 check for winning first place in the annual District Christmas Card contest.

Caleb Primera was presented a \$25.00 check for winning second place in the annual District Christmas Card contest.

Linda Groom, Art teacher Daniel 9th Grade Campus, was given a \$25.00 check to present to Zephyr Gunter for winning third place in the annual District Christmas Card contest.

President Bobby J Rigues opened the floor for Public Comments. They were;

Kittie France, PTO President, reported that \$40,000.00 had been raised in the Fall fundraiser, which is \$4,000.00 more than last year and will be split between the 8 schools, \$5,000 each. Over 7000 food items were collected for the Food Drive and will be taken to the Center of Hope. Dr. David Tillman, Community Partners Committee Chairman, reported the committee met in October and has developed a mission statement for Community Partners and will bring a list of final recommendations to the December or January Board meeting.

Mr. Dan Manning, Superintendent, reported:

~ Enrollment numbers on November 9, 2012 are 4701.

~ Ladycat Volleyball girls are headed to State. They will play in a state semi-final on Thursday in Garland at 5:00 P.M. If they win, they will play on Saturday, November 17 at 4:30 P.M.

~ The girls golf team is ranked third in State.

~ Boys football are the District Champs and will play this Friday against the Cleburne Yellow Jackets in Mansfield at 7:30 P.M.

~ Our Tennis Team has won district and reached the Regional quarterfinals.

~ Our Cross Country Team are also District Champions.

~ The Aledo PTO had an excellent Food Drive and thank you to our community and all our schools for their participation. Central Administration had a table set up and participated this year. Families in East Parker County will benefit from the Center of Hope.

~ Reminder that the School District will be closed November 19 -23 for the Thanksgiving Holidays.

~ The initial meeting of the Education Foundation will be in late November to start on the state paperwork that is required. Work with Foundation Innovation will begin in January.

~ The State lawsuit is entering into the third week and two-thirds of all the school districts in Texas are participating, which involves 3.4 million students. A decision should be made in late January.

~ On October 23, Mr. Rigues and Mr. Manning met with State Representative Phil King and presented Legislative Priorities for Aledo I.S.D. and where we stand on the voucher system to remind him that it will be harmful to families here in Aledo. President Bobby J Rigues introduced administrative report items:

~ Demographer's Update - Rocky Gardiner, from Templeton Demographics, gave a presentation of studies conducted and estimated growth in Parker County for the next few years. Aledo ISD will grow by 99 students next year.
