I, the undersigned, also agree to defend, indemnify and hold harmless the Releases from and against any and all claims, losses, costs, fees, (including but not limited to, reasonable attorneys' fees,) by whomever or wherever presented, including, but not limited to, personal injury, property damage, financial loss, wrongful death or any other loss or injury resulting in any manner from my participation in or pertaining to the Festival.
