



ACCOUNT BREAKDOWN CHART



As Of 7/22/2025 - Total Base Tax: \$ 9,900,361



As Of 7/22/2025 - Total Base Tax: \$ 9,900,361






PERSONAL PROPERTY EARLY TURNOVER

Comparison


