Any other school district employee required to complete the cybersecurity training shall complete the training as determined by the District.
- Government entities must annually certify their compliance with the training requirements by August 31 each year.
- All Aledo ISD employees have completed the chosen training as detailed in the attached certification that has been submitted to the State as required.
