- 1. Call Meeting to Order: Chairman Lau called the board meeting to order at 7:05 pm with Trustee Erickson, Trustee Kenyon, and Trustee Stoor in attendance. Vice-Chair Torgesen had previously asked to be excused from the meeting. Also, in attendance were Superintendent Molly Stein, Clerk Jonathan Balls, Principal Jess McMurray, Principal Rod Worthington, Principal Debra Daniels, High School Counselor Chris Ledbetter, one patron, and one student.
 - **1.1 Approval of Agenda:** Chairman Lau asked if there were any additional agenda items to be added to the posted agenda. Principal McMurray asked to add an FFA leadership overnight approval to other SSHS overnight action item. With no further changes brought forth to the posted agenda, Trustee Erickson made a motion to approve the agenda as amended. The motion was seconded by Trustee Kenyon. By a voice vote, the motion passed unanimously.
 - **1.2 Pledge of Allegiance:** Chairman Lau invited the trustees, administration, patrons, and student to join Clerk Balls in saying the Pledge of Allegiance.
- Executive Session: IDAHO CODE § 74-206(1)(b) Student: At 7:07 pm, Chairman Lau asked for a motion to go into executive session per Idaho Code § 74-206(1)(b) Student. Trustee Stoor made a motion to go into executive session per Idaho Code § 74-206(1)(b) Student. The motion was seconded by Trustee Erickson. Using a roll call vote: Chairman Lau Yes, Trustee Kenyon Yes, Trustee Stoor Yes. The motion passed unanimously.

While in executive session, high school administration and school board discussed the alternate education plan with a student and parent.

2.1. Decision regarding student: Once out of executive session, Trustee Erickson made a motion to approve the alternate education plan for Student Z. The motion was seconded by Trustee Stoor. By a voice vote, the motion passed unanimously.

3. Open Budget Hearing: Trustee Stoor made a motion to declare the budget hearing open for the 2019-2020 school year. The motion was seconded by Trustee Erickson. By a voice vote, the motion passed unanimously.

4. Continuous Improvement Plan / Administrative Reports:

- **4.1. Chairman:** Chairman Lau commented that the board had one of its better training sessions on finance and governance held the prior Friday at the District Office. He also said that the HS graduation was great.
- **4.2. Superintendent:** Superintendent Molly Stein mentioned that the district is wrapping up the school year and looking at the new requirements for next year's Continuous Improvement Plan.

- **4.3.1.** Soda Springs High School: Jess McMurray commented regarding the district wide math consortium committee that met earlier in the week and will meet throughout the summer to fulfill its objectives.
- **4.3.2.** Tigert Middle School: Debra Daniels reported that a few members of her faculty will travel to Boise to attend the Mastery Conference conducted by the State Department of Education.
