AGENDA ITEM: Consider Acceptance of Certification of Unopposed Candidates and

#### **BACKGROUND INFORMATION:**

- As stated in Board Policy BBB (LEGAL), the Board of Trustees consists of seven members serving terms of three years, with elections held annually.
- The terms of one-third of the Board Members, or as near to one-third as possible, expire each year.
- Election of Board Members is by position or place in accordance with Texas law.
- An Order of Election was approved by the Board of Trustees on January 18, 2022 for a Board of Trustees Election to be held on May 7, 2022.
- The deadline for interested parties to file an application as a candidate, or as a write-in candidate, for the May 7, 2022 election passed with only two applications received.
- Applications were received from Forrest Collins, Place 4, and Jennifer Taylor, Place 5.
- Texas Election Code Sections 2.051, 2.052, and 2.053 provide for declaring unopposed candidates elected to office and cancellation of an election.
- The following documents, Certification of Unopposed Candidates for Other Political Subdivisions (Not County) and Cancellation of Trustee Election on May 7, 2022 have been prepared in accordance with these provisions.
- Although the Board of Trustee election is being cancelled, the Aledo ISD Administration Building will still serve as a voting site for the May 7, 2022 election.
