Principal's General Narrative:

During the month of September, the State requires specific dyslexia screeners for Kinder - 2nd grade. Our K-2 teachers have been busy administering the TPRI required state assessment as well as the I-station assessment. The next step is to have a committee review the screening to determine students who qualify for Dyslexia testing or targeted interventions. The committee will meet on 10/11/2021.

On September 30th, we held our first monthly Parent Night. During parent night, we had 3rd graders perform and we also had a presentation by our interventionists on Dyslexia and we had an instructional "grab and go." Parents were provided with instructional materials they could take home to use with their children; this included math flash cards and reading board games. Parents meetings will be held monthly.

Tutorials have started to help close the achievement gap. Depending on the grade level, tutorials are being held before school, after school and even on Saturdays. The tutorials for 4th and 5th grade are to help us be in compliance with HB 4545

We continue to communicate with parents through our weekly newsletter. We have informed parents that student drop off in the morning should not be before 7:30 since staff is not on duty and the back gate for after school pick up does not open until 3:30. We have also informed parents that we have started a screentime shut off - this means district chromebooks for students in grade K-5 do NOT have access to the internet after 9:00pm.

4th and 5th graders have been attending the pep-rallies and all grade levels look forward to participating in the Homecoming Parade and events.
