 now scheduled on/or about Labor Day weekend or as soon as possible.
 \$47.000.00
- 2. Placement of at least nine caliche boulders under the shade of the six pine trees in front of school. These boulders will be 20" to 24" in height to be used for seating areas for students. The boulders will be extracted from caliche pits located on Ratliff Ranch. The work will be conducted under the supervision of Ratliff Ranch Property Manager, Carlos Mancha. The project will be done on a weekend, very soon.

The diameter of each boulder will vary.

Approx \$3,000 per boulder = \$27,000

The third project is the construction of a covered walkway inside the school's courtyard. That estimate is yet-to-come from Mueller Metal Building Construction and from architect, Cruz Castillo. Stay tuned for that.
