AGREEMENT

WHEREAS, LeAnn Bolhuis (hereinafter referred to as "Bolhuis") is employed as a probationary teacher by Independent School District No. 363, South Koochiching-Rainy River, Minnesota (hereinafter referred to as the "School District"); and

WHEREAS, as a teacher employed by the School District, Bolhuis is represented by the exclusive bargaining representative of teachers employed by the School District, the South Koochiching-Rainy River Education Association (hereinafter referred to as "the Association"); and

WHEREAS, Bolhuis is currently in her third year at the School District and thus is a probationary teacher in the School District pursuant to Minn. Stat. § 122A.40, Subd. 5; and

WHEREAS, the School District has furnished appropriate supervision to Bolhuis as provided in Minn. Stat. § 122A.40, Subd. 5 during Bolhuis's employment by the School District; and

WHEREAS, Minn. Stat. § 122A.40, Subd. 5 provides, in relevant part, that "during the probationary period any annual contract with any teacher may or may not be renewed as the school board shall see fit"; and

WHEREAS, the School Board of the School District is inclined to not renew Bolhuis's teaching contract after the end of the 2023–2024 school year due to perceived problems in Bolhuis's performance; and

WHEREAS, Bolhuis desires to have an additional year to improve her performance to the point that the School Board may, in its complete discretion, become satisfied with her performance; and WHEREAS, the School Board of the School District is willing to give Bolhuis one more school year to improve her performance before making a decision regarding renewal or nonrenewal of Bolhuis's teaching contract, provided she expressly waives any continuing contract rights arising out of her employment with the School District, and extend her probationary period by one additional school year; and

WHEREAS, Bolhuis has consulted with her exclusive bargaining representative, the Association, and/or her attorney and is fully advised of her legal rights pursuant to Minn. Stat. § 122A.40, particularly the right to continuing contract status after the completion of three consecutive years in the School District without being terminated and non-renewed in accordance with Minn. Stat. § 122A.40, Subd. 5 and any and all legal rights she may have regarding her employment by the School District, including any rights she may have under the 2023-2025 Master Agreement by and between the School District and the Association.

NOW, THEREFORE, IT IS HEREBY AGREED by and between the School District, Bolhuis and the Association as follows:

- 1. In spite of its concerns regarding Bolhuis's teaching performance, the School District shall not terminate and non-renew Bolhuis's probationary teaching contract effective the end of the 2023-2024 school year.
- 2. In consideration of the School District not terminating and non-renewing her probationary teaching contract effective the end of the 2023–2024 school year, Bolhuis knowingly and voluntarily waives any continuing contract rights she would otherwise be entitled to pursuant to Minn. Stat. § 122A.40 for the 2024–2025 school year, and

knowingly and voluntarily agrees to extend her probationary period through the end of the 2024–2025 school year.

- 3. It is specifically understood and agreed between the parties that the School District shall retain the full and complete discretion to either renew or not renew Bolhuis's teaching contract as it sees fit through the end of the 2024–2025 school year as a probationary teacher and Bolhuis knowingly and voluntarily waives any right to a hearing under Minn. Stat. § 122A.40 on such nonrenewal.
- 4. By executing this Agreement, the Association acknowledges that it is aware of the contents of this Agreement, that it has advised Bolhuis as to her rights pursuant to Minn. Stat. § 122A.40, and any and all rights Bolhuis may have regarding her employment by the School District, including any rights she may have under the collective bargaining agreement by and between the School District and the Association.
- 5. By executing this Agreement, the Association further acknowledges that the terms of this Agreement shall not constitute, nor be interpreted to constitute, a past practice.
- 6. Bolhuis acknowledges by executing this Agreement that there are no covenants, promises, undertakings or understandings outside of this Agreement other than those specifically set forth herein.
- 7. Bolhuis further acknowledges by executing this Agreement that she has had an opportunity to discuss the terms of this Agreement with her Association and/or attorney, that she has been fully advised of her legal rights pursuant to Minn. Stat. § 122A.40, and any and all rights she may have regarding her employment by the School District, including any rights she may have under the collective bargaining agreement by and between the School

District and the Association, and that there were no inducements or representations leading to the execution of this Agreement except as contained herein.

I have read the foregoing Agreement and by signing, hereby confirm that I fully understand and agree to its terms and application.
