Contract Award Recommendation for Pavement Projects

Frost Middle School / Grant Elementary

Dear Mr. Francis:

This letter transmits an update from Plante Moran Cresa (PMC) as it relates to the assignment to assist and advise Livonia Public Schools (LPS) in its selection of a Prime Contractor for the Projects listed above. This update represents the mutual efforts of PMC, NTH Consultants, LPS administration and staff (the Team) to present a framework in order to identify, evaluate and recommend a Prime Contractor firm for these Projects.

On March 16, 2018, Construction Documents were formally issued and made available. An advertisement for bids was published in a local newspaper and also posted to the required State of Michigan website.

On April 3, 2018, two (2) bid proposals were received for the Projects, and over the next several days were reviewed to determine the budget implications. An interview with the low bidder was conducted on April 5, 2018 with various members of the Team participating. The scope of work, permitting, and other particulars regarding the work were reviewed and clarified.

Upon completion of the interview, and after subsequent clarifications and discussions, the Team is recommending Nagle Paving Company for contract award at both schools. This includes acceptance of alternate F-1 at Frost Middle School in the amount of \$5,000.00. Including hard construction of \$177,380.00 and construction contingency of \$26,607.00, the total Project award recommendation equals \$203,987.00.

For the Prime Contractor, the costs for this work will be detailed in AIA Contract A105 – 2007 Standard Form of Agreement between Owner and Contractor, pending final review and approval of terms by district legal counsel.

Per our discussion and review of the Contractor's bids received, we have reviewed the Contractors' bid totals for the referenced project. Based on our review of the bids; specifically, the total bid to complete the work and the proposed contractor schedules, we recommend Livonia Public Schools retain Nagle Paving Company for the 2018 Bid Package No. 3 for Grant and Frost Schools' Pavement Improvement Project. According to Nagle's quote, the cost per school and total construction contract amount will be as follows:

Frost Middle School	\$52,890
Grant Elementary School	\$119,490
Frost Alternative No. 1 (new manhole structure)	\$5,000
TOTAL	\$177,380

Additionally, we recommend allocating contingency funds for the project at approximately 15 percent for unforeseen conditions that may be encountered.
