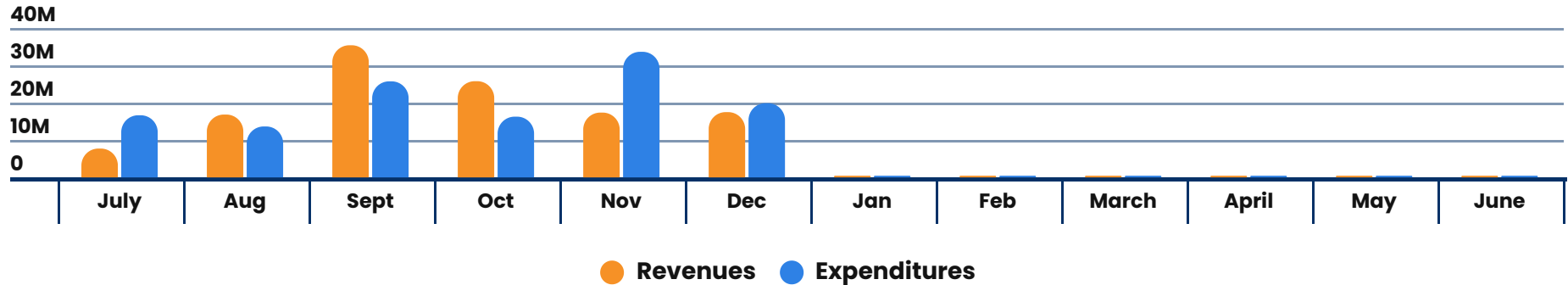

Monthly Revenues and Expenditures for FY26



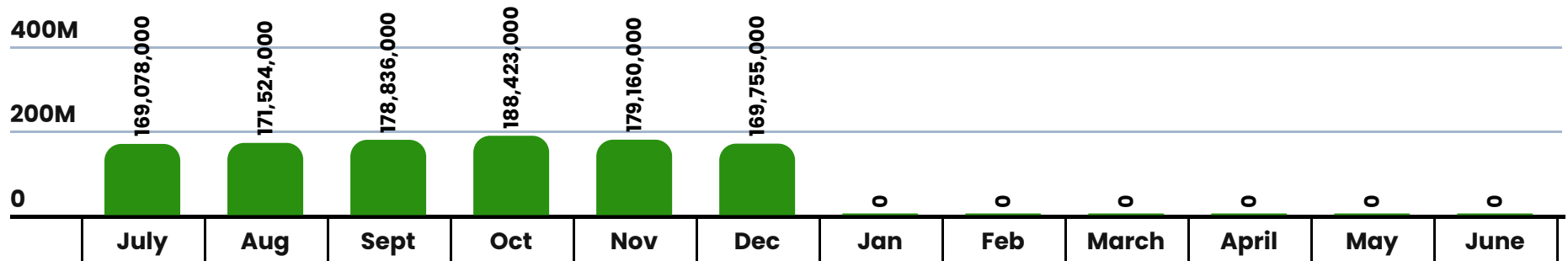

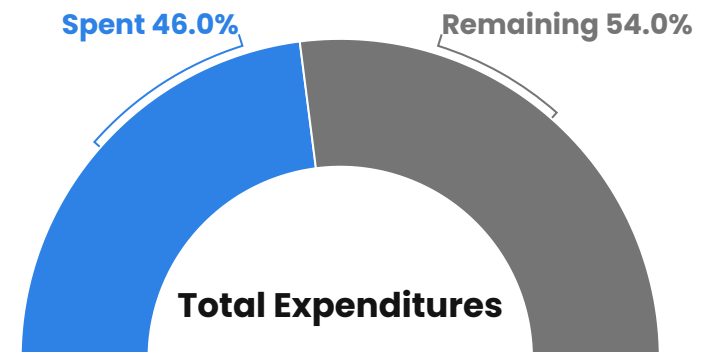
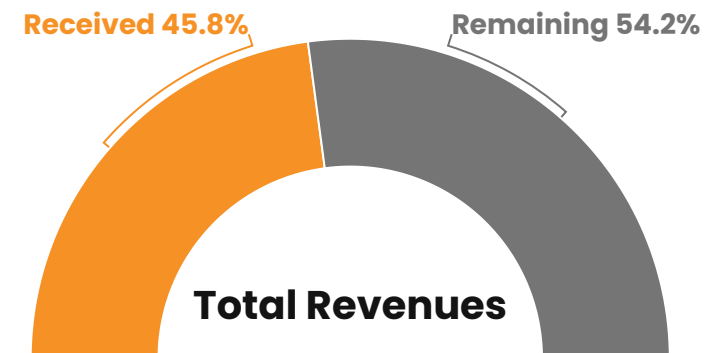

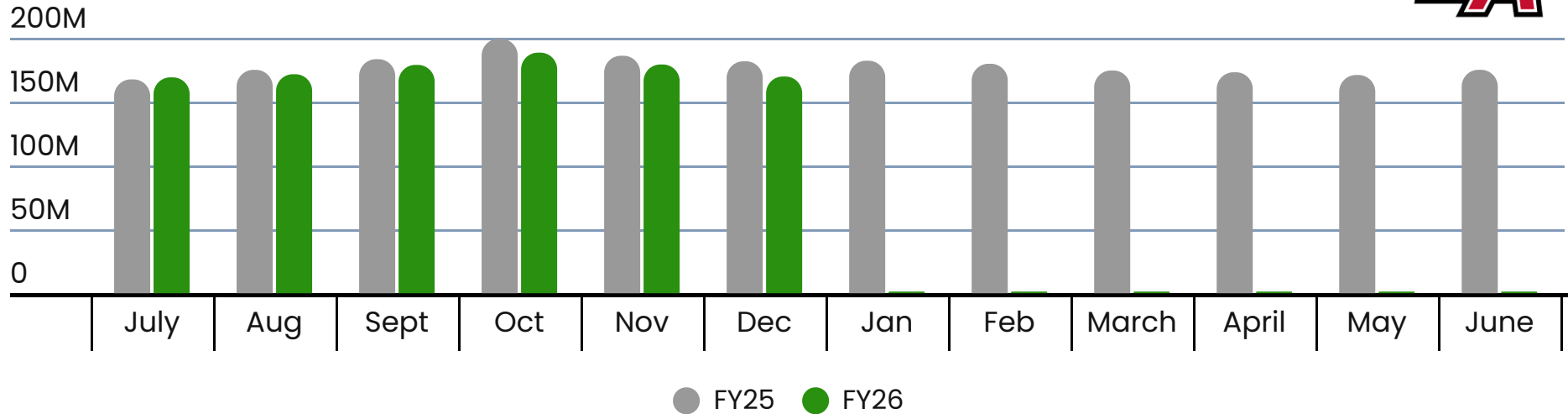

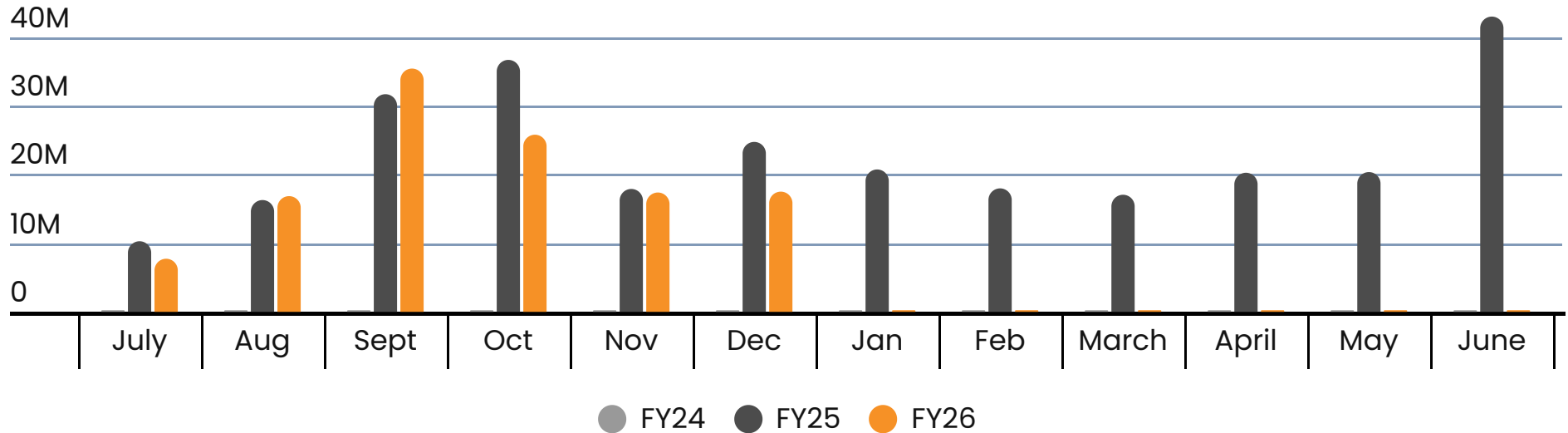

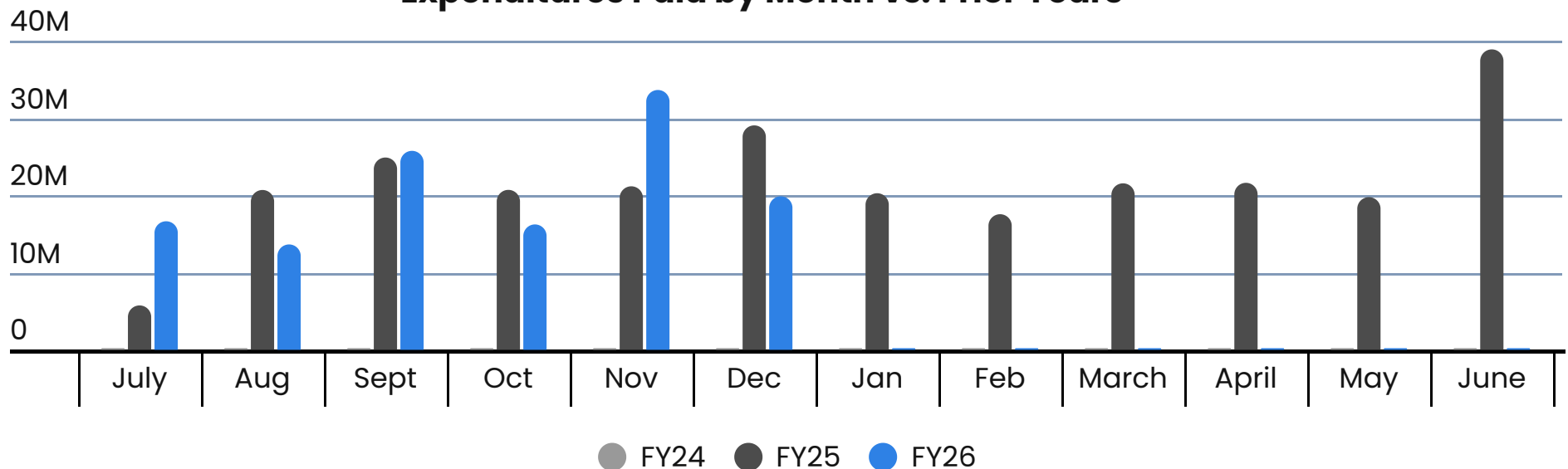
