Re: Review of Bids for Custodial Supplies

We would like to discuss the recommended purchase of custodial products for the 2014-15 school year at the next Finance Committee meeting. We prepared a Request for Proposal for 42 custodial supply items and for a just in time delivery system. We believe a just in time delivery system will be cost effective in the long run as we will not be storing and delivering custodial supplies from the warehouse.

Please find the attached recommendation memo and detailed bid tabulation from Harry Lau, Administrator of Operations & Facilities. Of the eight vendors that responded to the bid three were disqualified due to incomplete paperwork. Two vendors bid on only a few of the items and therefore were not included. Of the remaining vendors, HP Products has the lowest bid price. The cost detail on the bid tabulation is the pricing assuming we ordered one of each item from the list. Although one vendor has a lower overall cost, it is due to the fact that it is only 31 items bid. HP Products is the only vendor that priced all 42 items requested and is the recommended vendor. Based on the pricing and quantities used in prior years, we are estimating total costs of \$159,000 for 2014-15.

SUBJECT: Recommendation - Custodial Supplies - Just in Time On-Line

Ordering Bid

I am recommending and seeking approval to award HP Products the custodial supplies JIT on-line ordering bid. HP Products submitted bids on all 42 items that were on the bid list and had the lowest prices

for over 95% of the items listed.

Rational; using a JIT Custodial Supplies on-line ordering system will save Livonia Public Schools approximately 20% of the custodial supply budget by not bidding large quantities of paper, plastic and other custodial supplies, and storing them in our warehouse for distribution.

An estimated amount we would spend for the 2014-2015 school year for custodial supplies with HP Products is \$159,000.
