The District shall establish instructional objectives that relate to the essential knowledge and skills for grade-level subjects or courses. These objectives shall address the skills needed for successful performance in the next grade or next course in a sequence of courses.

Assignments, tests, projects, classroom activities, and other instructional activities shall be designed so that the student's performance indicates the level of mastery of the designated District objectives. ~~The student's mastery level shall be a major factor in determining the grade for a subject or course.~~

GUIDELINES FOR  
GRADING

The Superintendent or designee shall ensure that each campus or instructional level develops guidelines for teachers to follow in determining grades for students. These guidelines shall ensure that grading reflects a student's relative mastery of an assignment and that a sufficient number of grades are taken to support the grade average assigned. Guidelines for grading shall be clearly communicated to students and parents.

**The District shall permit a student who meets the criteria detailed in the** ~~In accordance with~~ grading guidelines, ~~a student shall be permitted~~ a reasonable opportunity to redo an assignment or retake a test for which the student received a failing grade.

~~GRANTING OF CREDIT~~

~~The District shall offer a student the following options to receive course credit for graduation, if all other conditions are satisfied:~~

- ~~1. Passing a one-semester course~~
- ~~2. Two-semester average of a full-year course is greater than or equal to a grade of 70~~
- ~~3. Credit by examination~~
- ~~4. Passing an approved correspondence course~~

<u>ELEMENTARY</u>	<u>In elementary grades 1 – 6, achievement in fine arts, health, and physical education shall be reported to parents as follows: “Excellent” (E), “Satisfactory” (S), “Needs Improvement” (N), or “unsatisfactory” (U).</u>
PARENT / TEACHER CONFERENCE	A conference shall be scheduled at the request of a teacher or a parent anytime during the school year.
GRADING PERIOD REPORTS	Teachers shall send out report cards to parents every nine weeks of a student’s performance in each class or subject.
PROGRESS REPORTS	Teachers shall send three-week and six-week progress reports to parents of a student whose performance is not satisfactory and/or who may be in danger of a failing mark for the grading period.
ACADEMIC DISHONESTY	Students found to have engaged in academic dishonesty shall be subject to grade penalties on assignments or tests and disciplinary penalties in accordance with the Student Code of Conduct. Academic dishonesty includes cheating or copying the work of another student, plagiarism, and unauthorized communication between students during an examination. The determination that a student has engaged in academic dishonesty shall be based on the judgment of the classroom teacher or another supervising professional employee, taking into consideration written materials, observation, or information from students.
