TITLE: Approval of Out of State Travel

BACKGROUND:

Approximate cost of the travel is \$16,746 and will be paid for by federal funds designated for staff development. One school day will be missed and substitutes are required.

Michelle Barcanic from Canyon del Oro High School requests permission to attend the International Baccalaureate Counseling Training in Houston, Texas, February 25-28, 2012. Approximate cost of the travel is \$2,520 and will be paid for by federal funds designated for staff development. Two school days will be missed and a substitute is not required.

Cymry DeBoucher from Canyon del Oro High School requests permission to attend the International Baccalaureate Film Level 1 Training in Kansas City, Missouri, April 13-16, 2012. Approximate cost of the travel is \$1,859 and will be paid for by federal funds designated for staff development. Two school days will be missed and a substitute is not required.
