## **Superintendent Report**

**Superintendent Update**: Superintendent Rappold stated there are no transfers; District administrators had metal detector training and now have different measures to make the process run more efficiently; Superintendent Rappold attended the MASS meeting for superintendents in Gt. Falls and discussed updates for legislature with regard to MHSA and OPI AND new funding formula.

MTSBA Model Policies 1st Reading: Superintendent Rappold stated that the DRAFT Policy Manual is attached for review along with the crosswalk comparison of Current BPS Policies. Second by Mr. Bremner. *Board discussion:* Mr. Bremner stated that BPS hired Jerry for BMS and his team did very well and he also coached his son in wrestling at BMS, as well as the state champ team in BMS & BHS FB; he challenges his wrestlers year-round to improve and he will have them in camps, and he will make these girls state champions too. Students, Maeleigh Gardner, Joss BlackWeasel, Nancy Harwood, and Aria Wellman spoke in opposition of hiring Jerry Racine as Head Girls Wrestling Coach. Crystal Tailfeathers-parent, stated that she does not want any retaliation to come back on these girls for stating how they feel. Following board members discussion Mr. RunningFisher called for a motion to hire. Motion to hire failed with Brian Gallup, Thomas Gervais, James Evans, Michael Hoyt voting opposed. Lockley Bremner voting for. Ms. YellowOwl abstained.

Second by Mr. Gallup. Mr. Evans stated that he hopes BPS staff are shown how to take care of the gym floors, including refinishing. Kellen Hall stated the new floor has multiple colors and a lot of white in it; if the floor did not have white water base paint and if they had used oil-based colors, we would not have to do this however, they used white and water-based paint and we will have to do this 2 times per year. The cleaning is being done properly but they did have a rock underneath the mop used to clean the floor and it scratched it up. Mr. Gallup stated there will be more costs as we move forward and there will be extra costs to do this again, this year. Mr. Evans asked if BPS can change to oil base. Mr. Hall stated they would have to change the whole image. Motion passed with James Evans, Donna YellowOwl, Thomas Gervais, Michael Hoyt, Lockley Bremner, Brian Gallup voting for.

Second by Mr. Gervais. *Board discussion:* Superintendent Rappold stated that some sensors are not working in restrooms and need to be replaced; they have already replaced BMS, VC, BES. Mr. Gallup stated they already had the discussion over elementary, this is a deterrent, vaping is happening and Mr. Gallup encouraged the Board to keep these in the restrooms. Sandi Campbell noted that new sensors will be added to restrooms and locker rooms. BHS Administration cannot constantly monitor this and need to have them installed. Travis Miller agreed and state they are adding 5 new plus sensors and 6 replacements. Motion passed with James Evans, Donna YellowOwl, Thomas Gervais, Michael Hoyt, Lockley Bremner, Brian Gallup voting for.
