#### ACTION

### BACKGROUND INFORMATION:

State statute requires that changes in the Budget adopted by the School Board at their June 2014 meeting (and amended at the August and October meetings) must be approved by the School Board if they change the major revenue sections of the budget or if they change any expenditure functions.

The attached budget amendment makes the following changes in the school district's budget:

- Transfers \$900 of Special Education Funds from Function 11 (Instruction) that had been budgeted for faculty travel, to Function 21 (Special Ed. Leadership) for travel by the Director. It should be noted that the Special Education Director Travel budget line originally had \$1,200 but that \$800 had been transferred to another account, so the net result of this transfer is a \$100 increase in the Director's Travel Account.
- Transfers the entire \$38,500 budget that had been set up in Function 41 (General Administration) to pay for the cost of the Potter/Randall County Appraisal District to Function 99 (Other Governmental Charges) which per TEA is the proper function for this expense.
- Transfers \$11,000 to Function 41 (General Administration) to pay for the cost of the Business Offices's TxEIS program (the accounting, purchasing, and payroll program for the school district.) Our original budget had \$7,000 for this expense budgeted in Function 53 (Technology) but we learned last summer that Function 41 was the more appropriate function for this expense. We also need to increase the budget for this item by \$4,000 because in September the server that handles these programs died. Rather than spend \$20,000 or more for two servers to run this program, we altered our contract with Region 16 so that they would host the program for us. Doing so has allowed us to receive more timely updates to the program and has allowed us to allocate the time and energy of the Technology Department more to the technology issues in the schools and less to administrative computing issues.

### BOARD ACTION REQUESTED:

We request that the Board approve the General Fund Budget Amendment #3 for the 2014-2015 budget as presented.
