H. Consider approval of One-Year Extension of RFP #2208-01 for Physical Therapy, Occupational Therapy, Speech Language Pathology, and School Psychology Services.

The motion was made by Laura Perez and seconded by Robert Quinones to approve the extension of contracts with SA Therapy in Motion, not to exceed \$150,000, and Assessment Intervention Management, LLC, (AIM) not to exceed \$75,000 for an additional year.
